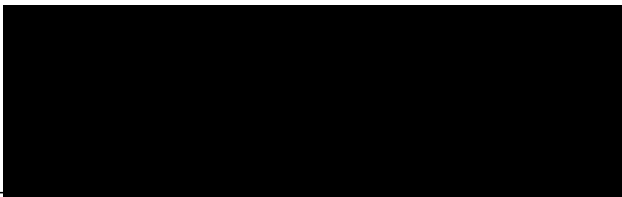
**Background**

The Illinois State Toll Highway Authority (“Tollway”) has previously purchased Fire Alarm and Sprinkler System Inspections, Repairs and Replacement Parts (Contract No. 15-0138RR) from Premier Specialties, LLC. It is in the best interest of the Tollway, pursuant to the terms and conditions of the contract, to renew the contract and increase the upper limit of compensation of said contract by an amount not to exceed \$45,000.00 for the purchase of additional Fire Alarm and Sprinkler System Inspections, Repairs and Replacement Parts.

**Resolution**

The renewal and associated increase to the upper limit of compensation of Contract No. 15-0138RR for the purchase of additional Fire Alarm and Sprinkler System Inspections, Repairs and Replacement Parts from Premier Specialties, LLC is approved in an amount not to exceed \$45,000.00 (increase from \$311,746.00 to \$356,746.00) during the current fiscal year. The Chief of Contract Services is authorized to issue the necessary purchase orders and contract purchase orders and any other necessary documents in connection therewith, and the Chief Financial Officer is authorized to issue warrants in payment thereof.
