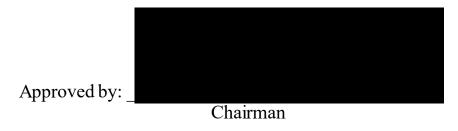

### **Background**

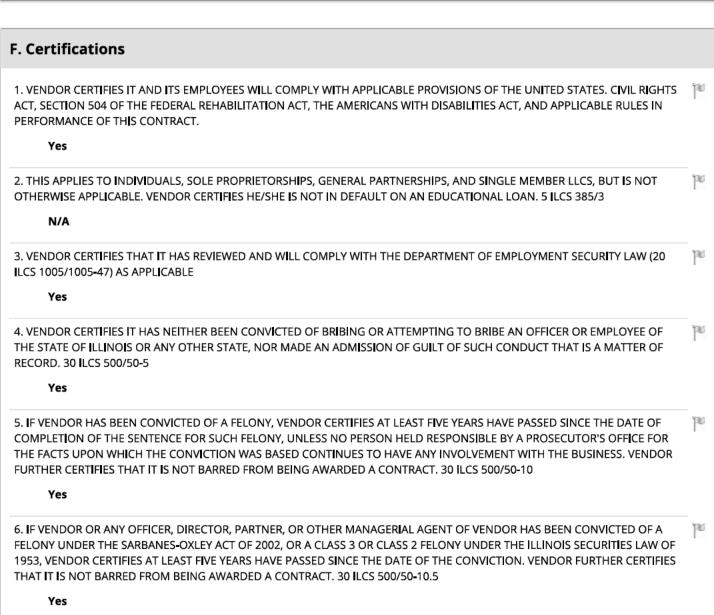

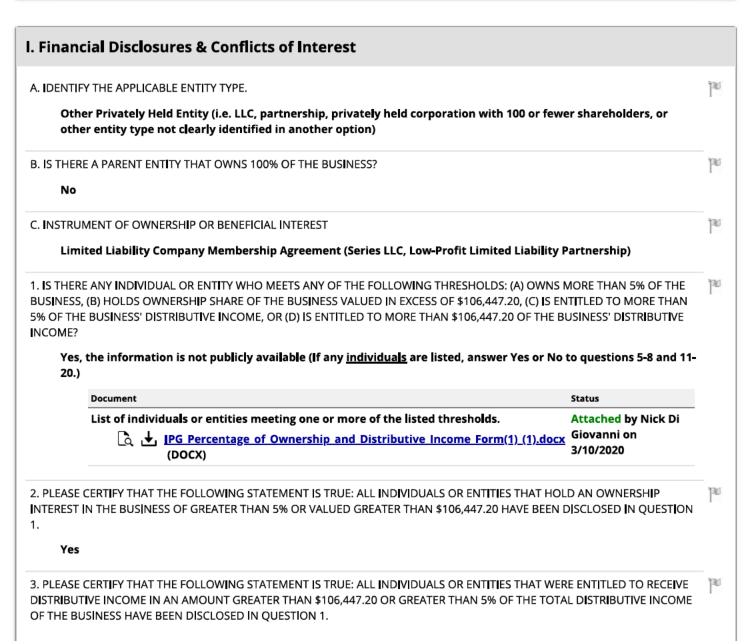
