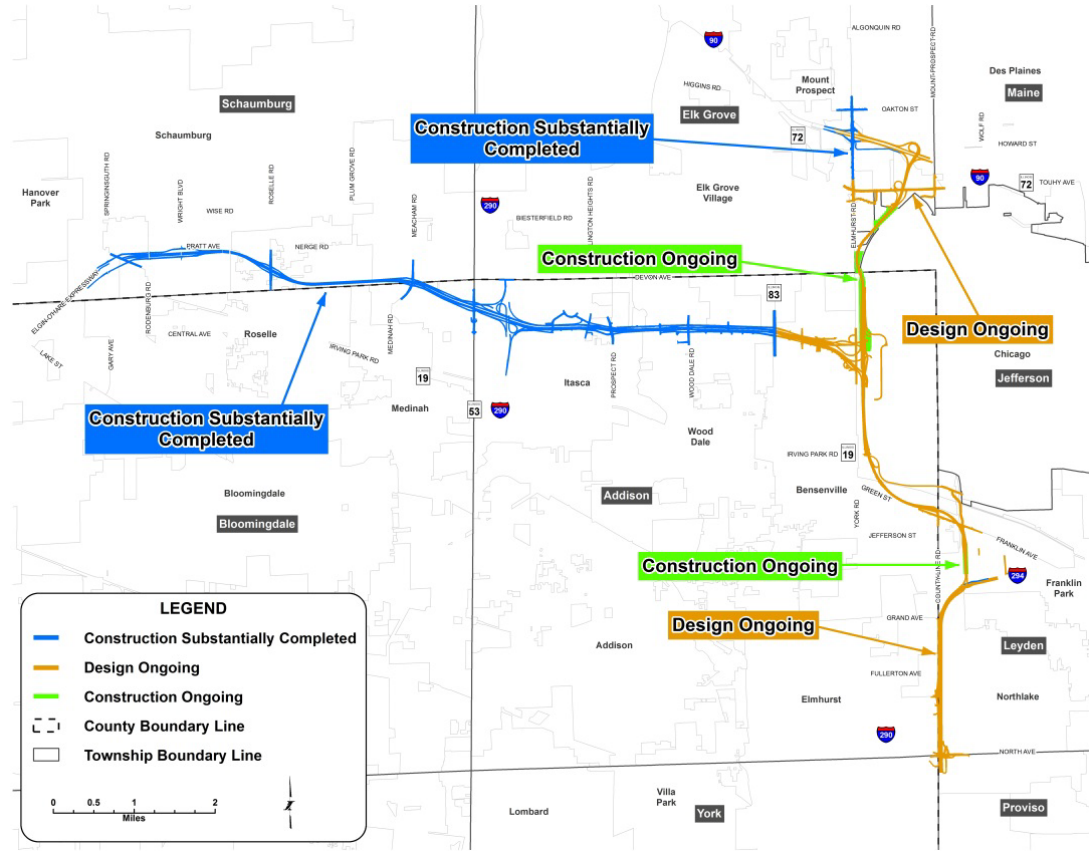

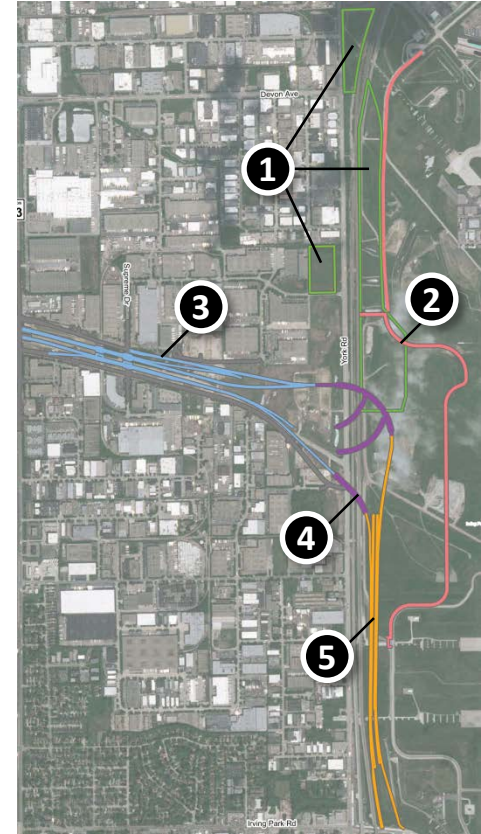
Western Access I-490 Interchange



Construction Status Update

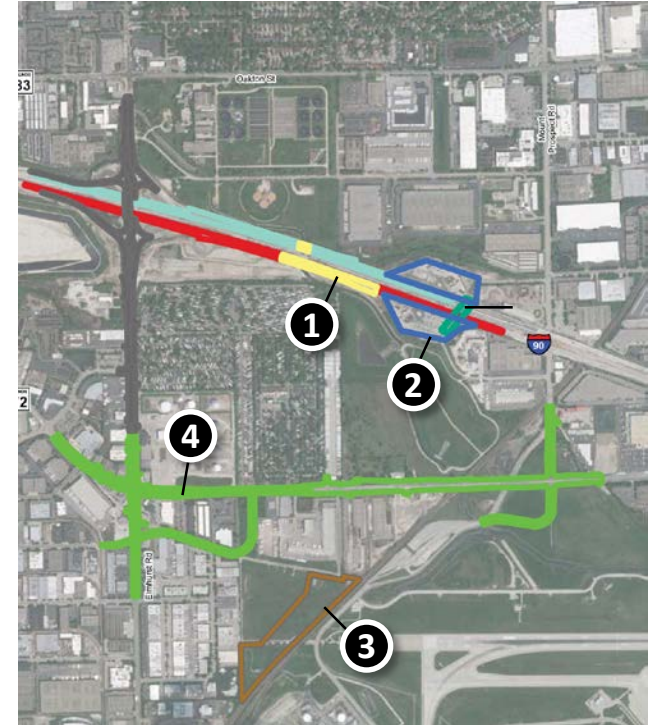
Advance Construction I-490 Interchange

- 1 Advance earthwork grading – CDA**
2018
- 2 O'Hare perimeter fence and road relocation**
COMPLETE: June 2018
- 3 I-490 Interchange - Illinois Route 83 to York Road**
2019 – 2020
- 4 I-490 Interchange ramp bridges**
2019 – 2021
- 5 Illinois Route 19 Interchange construction (North)**
2019 – 2021



Advance Construction – I-490 North Segment

- 1** I-90 Interchange bridges over Higgins Creek
2018 – 2020
- 2** I-490 bridges over I-90 and fuel station removal
2018 – 2020
- 3** Advance earthwork grading – CDA
2018 – 2018
- 4** Touhy Avenue over UPRR & I-490 – Cook County
2019 – 2021

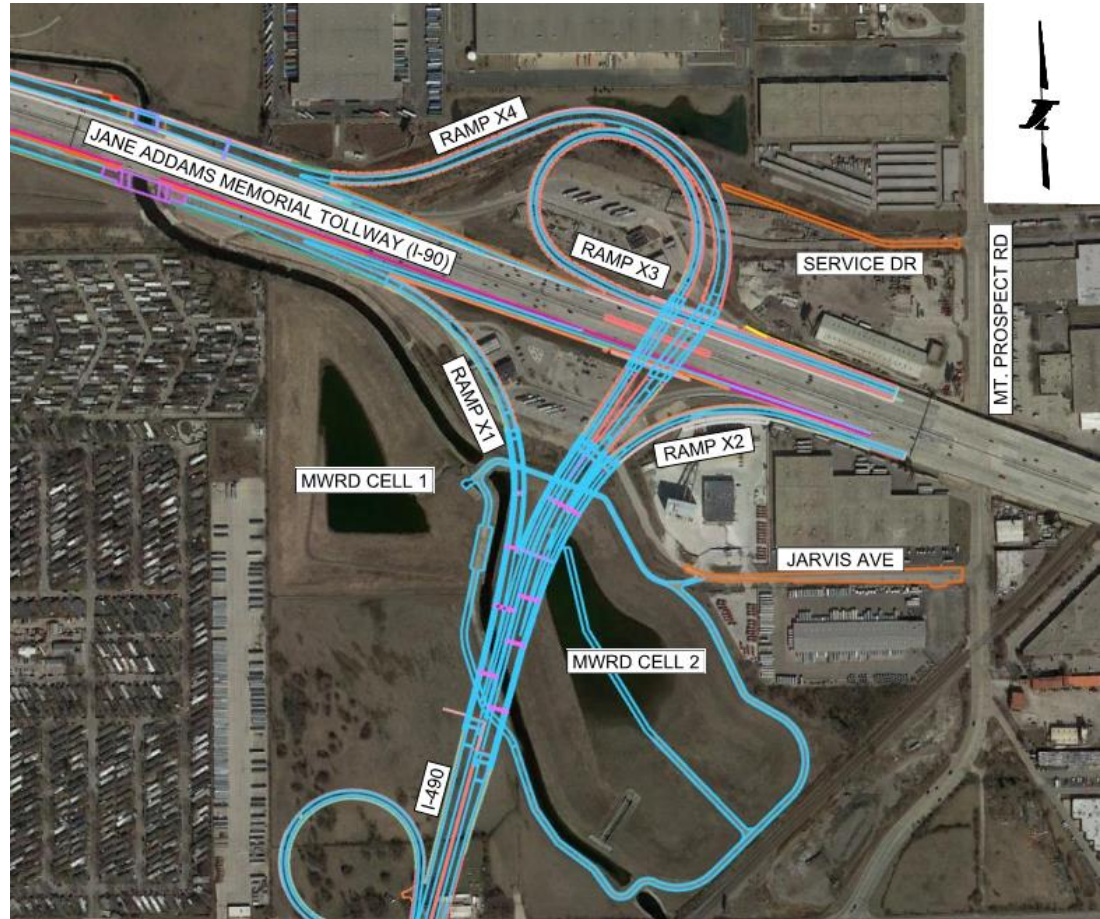


Advance Construction – I-490 South Segment

- 1** I-294 North Avenue Interchange – Cook County
2019 – 2020
- 2** Advance earthwork and retaining wall
2018 – 2019
- 3** I-294 (Grand Avenue to Wolf Road) and I-490 ramp
2019 – 2022
- 4** Advance fiber relocation installation
2018 – 2019

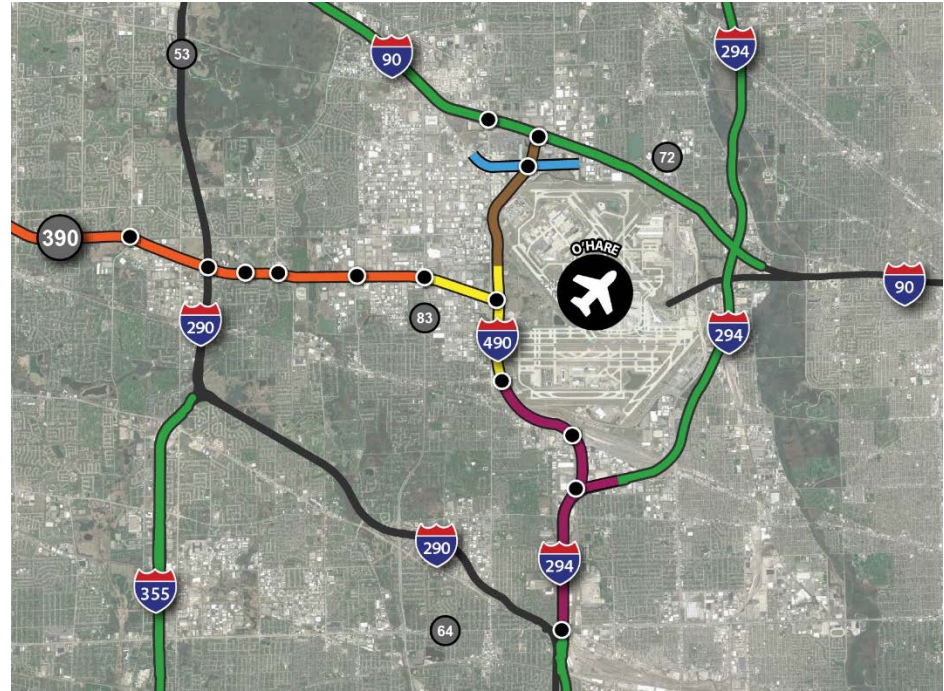
I-294/I-490 Interchange

Village of Franklin Park Project:

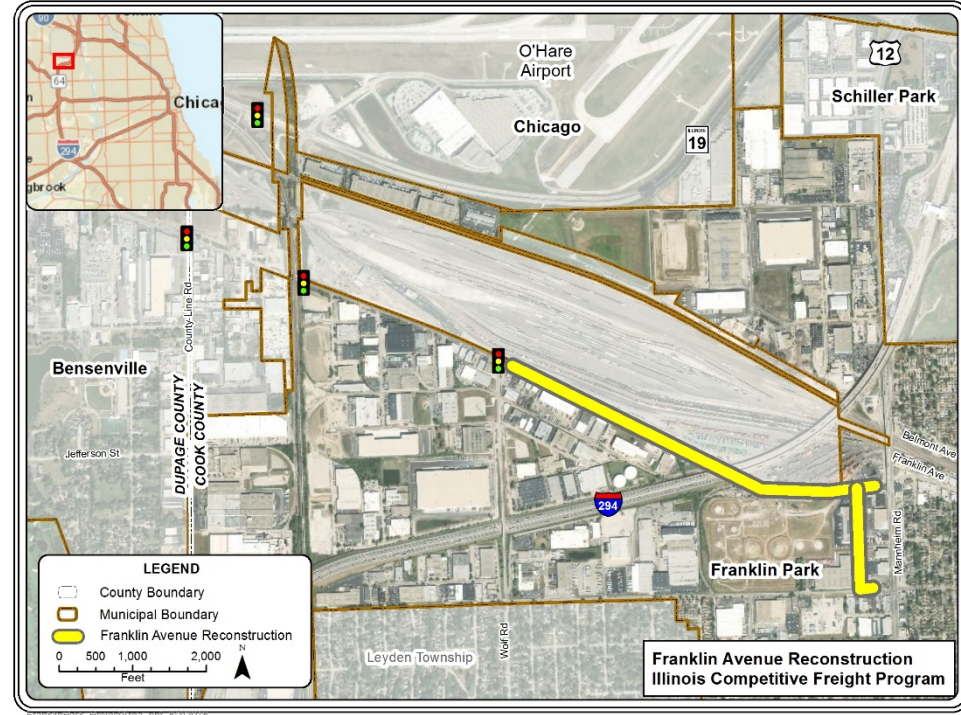
Total project cost \$27.6 M

Funding

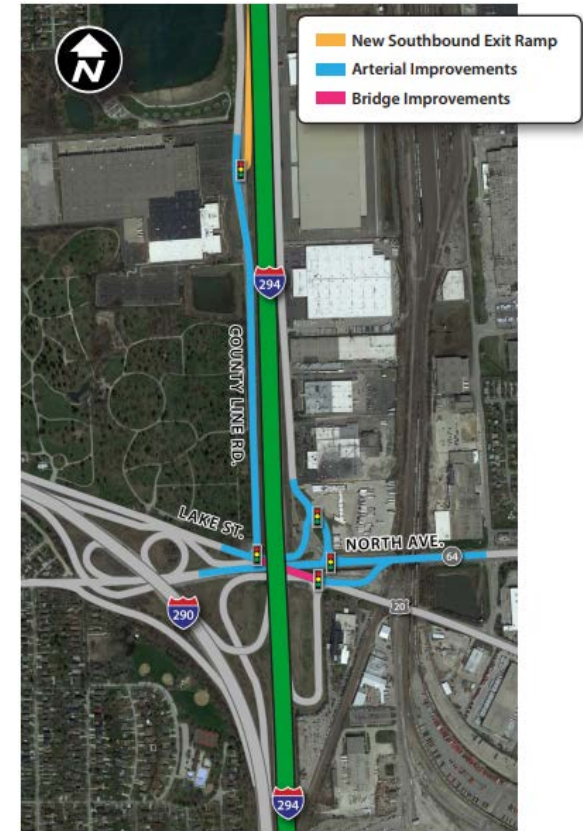
- Congestion Mitigation Air Quality (CMAQ) grant

- (2019 – 2020) - County Line Road Reconstruction

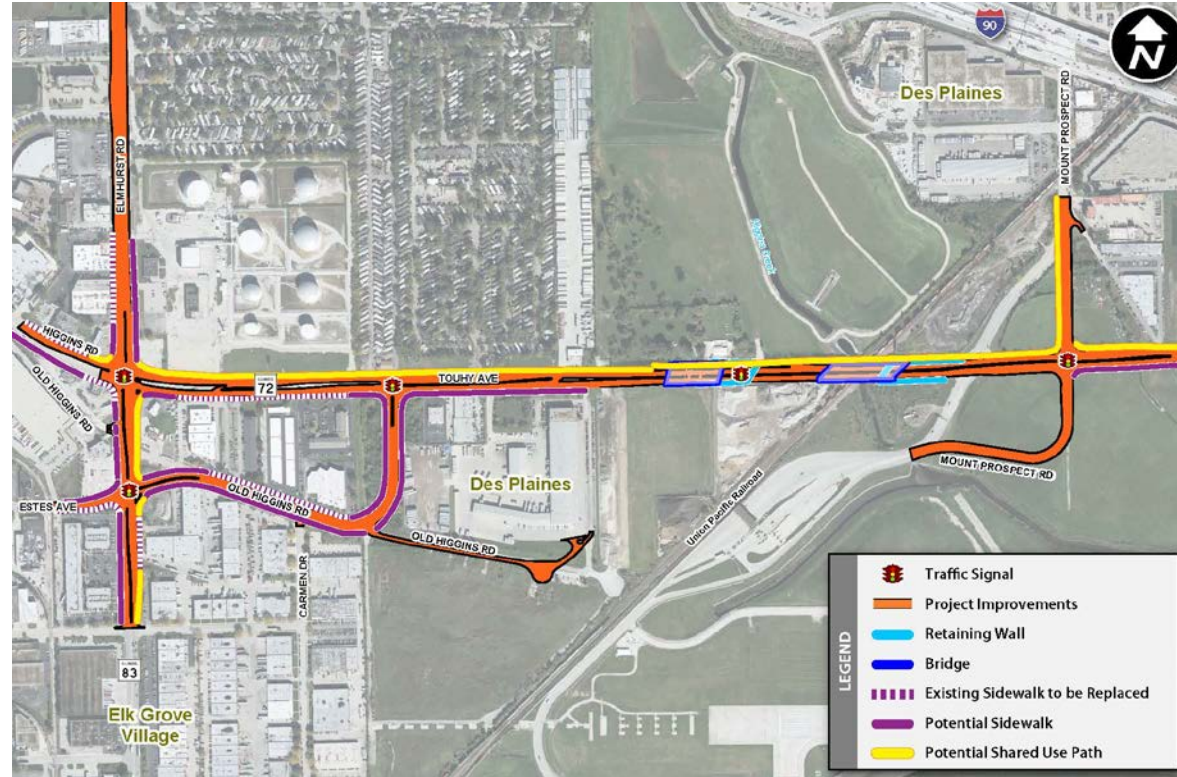
