
#### \*\*\*UPDATED\*\*\* CLOSURES RESCHEDULED ON ROBERTS ROAD AND 87<sup>TH</sup> STREET FOR CENTRAL TRI-STATE TOLLWAY (I-294) BRIDGE RECONSTRUCTION WORK Daytime lane closures and overnight full roadway closures with detours needed to safely accommodate bridge beam placement

**DOWNERS GROVE, IL –** Road closures on Roberts Road and 87<sup>th</sup> Street have been rescheduled to begin during the week of July 26 to accommodate mainline bridge beam placement on the Central Tri-State Tollway (I-294) Project. This will include daytime closures on Roberts Road, overnight roadway closures with detour on 87<sup>th</sup> Street and overnight lane closures on northbound I-294.

These temporary closures are necessary to safely accommodate the placement of bridge beams on I-294 over Roberts Road and 87<sup>th</sup> Street. Electronic message signs and construction signage will be in place in advance to alert drivers to each of the overnight closures. Up-to-date closure information will be posted on the Tollway website in the <u>Daily Construction Alert</u>. All work is weather dependent.

On Roberts Road, beginning the week of July 26 and continuing through August 3, one southbound lane on Roberts Road is scheduled to close daily from 2 p.m. to 6 a.m. to provide space for bridge beam delivery and storage.

On 87<sup>th</sup> Street under I-294, up to two nights of full roadway closures will be scheduled during the week of July 26 for bridge beam placement. The closures will begin at 9 p.m. each night with the roadway reopening by 5 a.m. the following morning. During the roadway closures, a posted detour will route traffic via Cork Avenue, 95<sup>th</sup> Street and Harlem Avenue.



Once work at 87<sup>th</sup> Street is complete, up to four nights of roadway closures on Roberts Road under I-294 will be scheduled. During the roadway closures, a posted detour will route traffic via 95<sup>th</sup> Street, 88<sup>th</sup> Avenue/Cork Avenue and 79<sup>th</sup> Street. The closures will begin at 9 p.m. each night with the roadway reopening by 5 a.m. the following morning.



To accommodate bridge replacement work, traffic is currently reduced in both directions on Roberts Road and 87<sup>th</sup> Street. Traffic will remain in this configuration through 2022 for bridge work. Traffic on I-294 between the 83<sup>rd</sup> Street Toll Plaza and 95th Street is currently shifted with two northbound lanes traveling in counterflow lanes on the southbound side of I-294.

Construction in this area is being coordinated with the Illinois Department of Transportation, Cook County Department of Transportation and Highways, Village of Bridgeview, Village of Burr Ridge, City of Countryside, City of Hickory Hills, Village of Hodgkins, Village of Indian Head Park, Village of Justice, as well as local fire and police departments.

In 2021, the Illinois Tollway is continuing work on southern section of the Central Tri-State Project between I-55 and 95<sup>th</sup> Street, which includes rebuilding and widening the roadway to five lanes in both directions, including construction of new I-294 bridges over I-55, Flagg Creek, 87th Street and Roberts Road, as well as reconstructing shoulders including adding Flex Lanes. This work is scheduled to be complete by the end of 2023.

The \$4 billion Central Tri-State Tollway (I-294) Project is reconstructing and widening the roadway between Balmoral Avenue and 95<sup>th</sup> Street to provide congestion relief, update old infrastructure to meet current and future transportation demand and address regional needs. This work is part of the Tollway's 15-year, \$14 billion capital program, *Move Illinois: The Illinois Tollway Driving the Future.* More than 220,000 vehicles use the Central Tri-State Tollway daily.

## Work Zone Safety

Construction zone speed limits are in effect in all construction zones 24/7 and drivers should continue to watch for changing traffic patterns and use caution, especially when workers are present. On I-294, a 45 mph work zone speed limit is in effect throughout the construction season.

The Illinois Tollway reminds motorists that the "Move Over Law" requires motorists to change lanes or to slow down and proceed with caution when passing any vehicle on the side of the road with hazard lights activated. If you see flashing lights ahead, please move over or slow down.

Illinois State Police have zero tolerance for drivers speeding in work zones or failure to comply with the Move Over Law. The minimum penalty for speeding in a work zone is \$250 with up to a \$25,000 fine and a 14-year jail sentence for hitting a roadway worker. Penalties for failure to slow down or move over for a vehicle on the shoulder with flashing lights includes up to a \$10,000 fine, 2-year suspension of driving privileges and jail time, in extreme cases.

## About Move Illinois

The Illinois Tollway's 15-year, \$14 billion capital program, *Move Illinois: The Illinois Tollway Driving the Future*, is improving mobility, relieving congestion, reducing pollution, creating as many as 120,000 jobs and linking economies throughout the region. The first nine years of *Move Illinois* is on schedule and within budget, delivering the rebuilt and widened Jane Addams Memorial Tollway (I-90) as a state-of-the-art 21<sup>st</sup> century corridor and opening a new interchange connecting the Tri-State Tollway (I-294) to I-57. Progress continues on projects addressing the remaining needs of the existing Tollway system, delivering the Elgin O'Hare Western Access Project and reconstruction of the Central Tri-State Tollway (I-294).

#### About the Illinois Tollway

The Illinois Tollway is a user-fee system that receives no state or federal funds for maintenance and operations. The agency maintains and operates 294 miles of roadways in 12 counties in Northern Illinois, including the Reagan Memorial Tollway (I-88), the Veterans Memorial Tollway (I-355), the Jane Addams Memorial Tollway (I-90), the Tri-State Tollway (I-94/I-294/I-80) and the Illinois Route 390 Tollway.
