OVERNIGHT AND WEEKEND-LONG CLOSURES RESCHEDULED ON ROBERTS ROAD AND 87<sup>TH</sup> STREET FOR CENTRAL TRI-STATE TOLLWAY (I-294) BRIDGE RECONSTRUCTION WORK

Full roadway closures with detours needed to safely accommodate bridge beam work

**DOWNERS GROVE, IL –** Road closures with detours have been rescheduled to begin in June on Roberts Road and 87<sup>th</sup> Street to accommodate bridge beam removal for the Central Tri-State Tollway (I-294) Project. In addition to overnight closures, this work will require weekend-long closure of both local roads at the intersection under I-294. Delays are expected.

The temporary closures are necessary to safely accommodate the removal of bridge beams on I-294 over Roberts Road and 87<sup>th</sup> Street. Electronic message signs and construction signage will be in place in advance to alert drivers to each of the closures and detours. Up-to-date closure information will be posted on the Tollway website in the <u>Daily Construction Alert</u>. All work is weather dependent.

On Roberts Road under I-294, a full roadway closure is scheduled for overnight Tuesday, June 2, and if needed, on Wednesday, June 3. The closure on Roberts Road will begin at 9 p.m. with the roadway reopening by 5 a.m. the following morning. During the closure, a posted detour will route traffic via 95<sup>th</sup> Street, 88<sup>th</sup> Avenue/Cork Avenue and 79<sup>th</sup> Street (see map below).

If the work at Roberts Road is completed in one night, a weekend-long, full closure of both 87<sup>th</sup> Street and Roberts Road will be scheduled to begin at 9 p.m. on Friday, June 3, and continue through 5 a.m. on Monday, June 6, with posted detours for each roadway. (see maps below). If the work at Roberts Road requires two nights, the weekend-long closure will be scheduled to begin at 9 p.m. on Friday, June 10, and continue through 5 a.m. on Monday, June 13.

In addition, on 87<sup>th</sup> Street under I-294 a full roadway closure is scheduled for overnight Monday, June 6, and if needed on Tuesday, June 7. The closure on 87<sup>th</sup> Street will begin at 9 p.m. with the roadway reopening by 5 a.m. the following morning. During the closure, a posted detour will route traffic via Cork Avenue, 95<sup>th</sup> Street and Harlem Avenue (see map below).





To accommodate bridge replacement work, traffic is currently reduced in both directions on Roberts Road and 87th Street. Traffic will remain in this configuration through 2022 for bridge work.

Construction in this area is being coordinated with the Illinois Department of Transportation, Cook County Department of Transportation and Highways, Village of Bridgeview, City of Hickory Hills, Village of Justice, as well as local fire and police departments.

In 2022, the Illinois Tollway is continuing work on southern section of the Central Tri-State Project between I-55 and 95<sup>th</sup> Street, which includes rebuilding and widening the roadway to five lanes in both directions, including construction of new I-294 bridges over I-55, Flagg Creek, 87th Street and Roberts Road, as well as reconstructing shoulders including adding Flex Lanes. This mainline work is scheduled to be complete by the end of 2023.

The \$4 billion Central Tri-State Tollway (I-294) Project is reconstructing and widening the roadway between Balmoral Avenue and 95<sup>th</sup> Street to provide congestion relief, update old infrastructure to meet current and future transportation demand and address regional needs. This work is part of the Tollway's 15-year, \$14 billion capital program, *Move Illinois: The Illinois Tollway Driving the Future.* More than 220,000 vehicles use the Central Tri-State Tollway daily.

### **Work Zone Safety**

Construction zone speed limits are in effect in all construction zones 24/7 and drivers should continue to watch for changing traffic patterns and use caution, especially when workers are present. On I-294, a 45 mph work zone speed limit is in effect throughout the construction season. On 87th Street and Roberts Road, a 35 mph work zone speed limit is in effect.

The Illinois Tollway reminds motorists that the "Move Over Law" requires motorists to change lanes or to slow down and proceed with caution when passing any vehicle on the side of the road with hazard lights activated. If you see flashing lights ahead, please move over or slow down.

Illinois State Police have zero tolerance for drivers speeding in work zones or failure to comply with the Move Over Law. The minimum penalty for speeding in a work zone is \$250 with up to a \$25,000 fine and a 14-year jail sentence for hitting a roadway worker. Penalties for failure to slow down or move over for a vehicle on the shoulder with flashing lights includes up to a \$10,000 fine, 2-year suspension of driving privileges and jail time, in extreme cases.

# About Move Illinois

The Illinois Tollway's 15-year, \$14 billion capital program, *Move Illinois: The Illinois Tollway Driving the Future*, is improving mobility, relieving congestion, reducing pollution, creating as many as 120,000 jobs and linking economies throughout the region. The Illinois Tollway is a user-fee system that receives no state or federal funds for maintenance and operations. The agency maintains and operates 294 miles of roadways in 12 counties in Northern

Illinois, including the Reagan Memorial Tollway (I-88), the Veterans Memorial Tollway (I-355), the Jane Addams Memorial Tollway (I-90), the Tri-State Tollway (I-94/I-294/I-80) and the Illinois Route 390 Tollway.
