

MOVE ILLINOIS CAPITAL PROGRAM DATA THROUGH NOVEMBER 2022

In 2012, the Illinois Tollway launched the 15-year, \$12 billion capital program, *Move Illinois: The Illinois Tollway Driving the Future*. In 2017, the Board of Directors expanded the program to \$14 billion.

MOVE ILLINOIS PROGRAM BUDGET OVERVIEW (2012-2022)

\$12.0 billion or **84.0%** of the program budget committed

- **57.3 billion**, or approximately **51.4%**, in construction work
- **53.0 billion**, or approximately **21.0%**, in consultant services
- **51.7 billion**, or approximately **12.0%**, in other costs (utilities, ROW, misc.)
- \$209.7 million in reimbursement agreements has been approved; reducing overall program costs by 1.5%

69.8% of the *Move Illinois* Program is complete (work in place)








CENTRAL TRI-STATE TOLLWAY (I-294) PROJECT DATA THROUGH NOVEMBER 2022




CORRIDOR STATUS DIAGRAM


