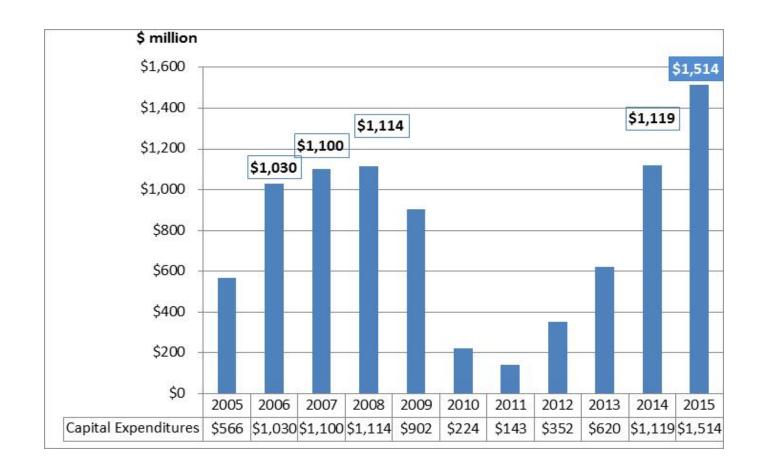


2015 Capital Program

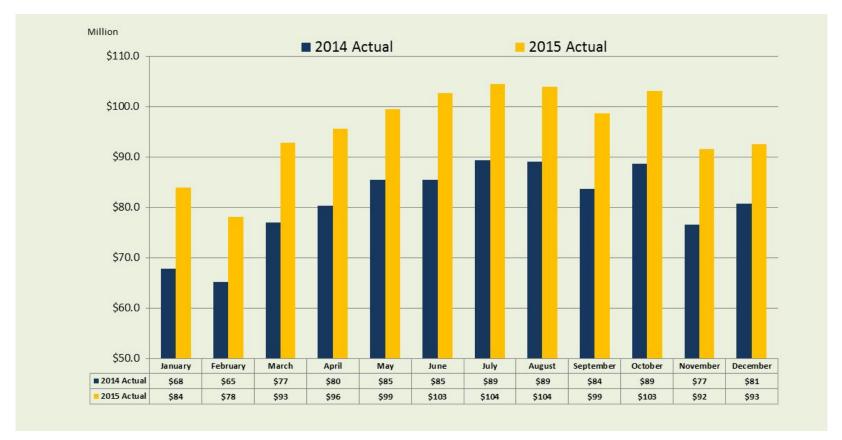

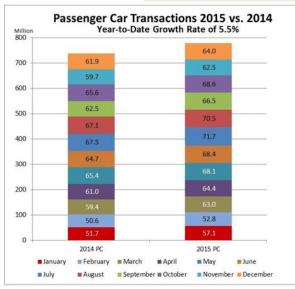

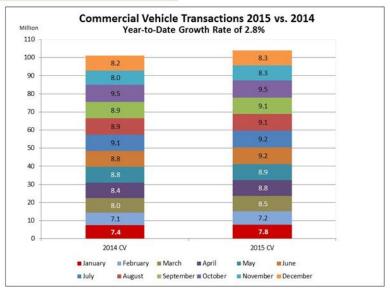
