Record of Meeting | August 27, 2015

The Illinois State Toll Highway Authority (the "Tollway") Board of Directors met in regular session on Thursday, August 27, 2015 in the Board Room of Tollway Headquarters in Downers Grove, Illinois. The Meeting was held pursuant to By-Laws of the Tollway upon call and notice of the Meeting executed by Chairman Robert J. Schillerstrom and posted in accordance with the requirements of the Illinois *Open Meetings Act*. The Meeting was open to the public.

Call to Order / Pledge of Allegiance / Roll Call

Chairman Bob Schillerstrom called the Meeting to order at approximately 9:00 a.m., stating that this is the regularly scheduled meeting of the Board of Directors of the Tollway. He invited attendees to rise and join in the Pledge of Allegiance. He then asked the Board Secretary to call the roll, those Directors present and absent being as follows:

The Board Secretary declared a quorum present.

Chairman's Items

Without objection, Chairman Schillerstrom requested that the order of the Meeting agenda be amended to first address **Chairman's Item 6**, the signing of a Statement of Support, pledging the Tollway's support to Guard and Reserve employees.

Chairman Schillerstrom welcomed to the Meeting representatives of the Illinois Committee of Employer Support of the Guard and Reserve ("ESRG"): Michael Holub, Ed LeTourneau and Kendall Marks. He then invited Mr. Holub to address the Board.

Mr. Holub, ESRG Vice-Chair and Public Affairs Director, addressed the Board. He first provided a brief overview of the mission of the ESGR, a Department of Defense office, to foster a culture in which all employers support and value the employment and military service of members of the National Guard and Reserve in the United States. He expressed his appreciation to the Tollway for its long history of support for employees who are veterans or currently serving in this nation's military. He then concluded by inviting Chairman Schillerstrom to sign the Statement of Support on behalf of the Tollway.

[Director Dotson entered at 9:10 a.m.]

Chairman Schillerstrom invited Board members and the Executive Director to join him at the table to sign the Statement of Support, pledging that:

- The Tollway fully recognizes, honors and complies with the *Uniformed Services Employment and Reemployment Rights Act*.
- The Tollway will provide managers and supervisors with the tools needed to effectively manage those employees who serve in the Guard and Reserve.
- The Tollway appreciates the values, leadership and unique skills service members bring to the workforce and will encourage opportunities to hire guardsmen, reservists and veterans.
- The Tollway will continually recognize and support this country's service members and their families in peace, in crisis and in war.

[At this time, the Tollway Board and Executive Director participated in the signing ceremony. The Meeting was paused briefly to allow an opportunity for photos.]

Chairman Schillerstrom thanked those Tollway employees in attendance, representing about half of the 108 total number who have previously served in the military or are currently serving in the Reserves and National Guard. He expressed the Tollway's pride and appreciation for the sacrifices they make to defend our freedoms. He then asked that they stand and be recognized.

In conclusion, Mr. Holub presented Chairman Schillerstrom with the ESGR "Challenge Coin!" Chairman Schillerstrom thanked Mr. Holub and those men and women who bring the qualities of their military experiences to their Tollway jobs.

Public Comment

Chairman Schillerstrom opened the floor for public comment, requesting that speakers limit their remarks to three minutes.

Michael Stevens, President and CEO of Lake County Partners, addressed the Board. Mr. Stevens provided a brief overview of his organization, a non-profit economic development corporation working to maintain economic vitality and quality of life in Lake County. He then communicated the strong support of the Lake County Partners' Board of Governors for the Illinois Route 53/120 Project, emphasizing the importance of the Project to providing congestion relief and to the continued economic development of the region. Mr. Stevens concluded by commending the Board for hiring Executive Director Bedalov, a former colleague, whom he holds in high regard. Chairman Schillerstrom thanked Mr. Stevens for his comments.

Susan Zingle, member of Livable Lake County, addressed the Board. She commented that Livable Lake County, a grassroots group founded to preserve the livability and natural resources of Lake County, is opposed to the Illinois Route 53/120 Project. She additionally expressed concern with elected officials addressing the Board during public comment portions of Tollway meetings. Chairman Schillerstrom thanked Ms. Zingle for her comments.

Robert Baker, President of Save our Community Coalition, addressed the Board. Mr. Baker thanked Gustavo Giraldo, Chief of Diversity and Strategic Development, for recently meeting with him. He then expressed concern about the relatively lower level of participation of African American firms in the \$1.8 billion in planned Capital Program investments for 2015. He expressed his concurrence with comments made at the previous Board meeting by Director Gonzalez recommending that the Tollway allocate additional resources to all Tollway diversity programs, including within Zone 1, in an effort to expand participation of African American firms in Tollway construction contracts. Chairman Schillerstrom thanked Mr. Baker for his comments.

Donald Hamberger, Tollway equipment operator laborer, addressed the Board. Mr. Hamburger expressed his objection to the elimination of the use of transponders by Tollway employees for commuting purposes. He then requested that the Board consider issuing credits, particularly during the winter season, to Tollway maintenance workers for commuting purposes. Chairman Schillerstrom thanked Mr. Hamberger for his comments.

Chairman Schillerstrom called for a motion to approve **Chairman's Item 1**, the Minutes of the regular Board of Directors meeting held on July 23, 2015. Director Banks made a motion for approval; seconded by Director Gonzalez. Chairman Schillerstrom asked if there were any questions, concerns or requests for discussion. Hearing none, Chairman Schillerstrom called for a vote. The motion was approved unanimously.

Chairman Schillerstrom stated that action on Chairman's Item 2, the Minutes of the Executive Session of the Board meeting held on July 23, 2015, will be deferred until after consideration in Executive Session.

Chairman Schillerstrom then asked if Director Gomez had any activity to report from the recently held meeting of the Finance, Administration and Operations ("FAO") Committee, on which he serves as Committee Chair, other than a summary of those items currently placed on the Board agenda with the Committee's recommendation. Director Gomez responded that he had no additional activity to report.

Chairman Schillerstrom called for a motion to approve **Chairman's Item 4**, Resolution 4.0/4, designating Director Corey Brooks as a member of the FAO Committee through amendment to the prior resolution. Director Sauer made a motion for approval; seconded by Director Johnson. Chairman Schillerstrom asked if there were any questions, concerns or requests for discussion. Hearing none, Chairman Schillerstrom called for a vote. The motion was approved unanimously.

Chairman Schillerstrom then reported on an incident which occurred recently in a work zone on the Jane Addams Memorial Tollway (I-90). He described that a vehicle was struck by another, causing the former to burst into flames and leaving its driver unconscious inside. He further stated that two Tollway maintenance workers and an Illinois State Police District 15 trooper were among those on hand to come to the rescue of this driver. Chairman Schillerstrom then asked Tollway maintenance section supervisor Noel Rodriguez, Tollway equipment operator laborer Ryan Zierer and State Trooper Arthur Trillet to please stand. With the expressed purpose to recognize these men for their bravery, Chairman Schillerstrom then read aloud proposed Resolution 4.0/5 commending these individuals.

Chairman Schillerstrom then called for a motion to approve **Chairman's Item 5**, Resolution 4.0/5 recognizing Illinois State Police and Tollway employees for courageous service in the line of duty. Director Johnson made a motion for approval; seconded by Director Banks. Chairman

Schillerstrom asked if there were any questions, concerns or requests for discussion. Hearing none, Chairman Schillerstrom called for a vote. The motion was approved unanimously.

Chairman Schillerstrom then called on Greg Bedalov, Executive Director.

Executive Director

Executive Director Bedalov announced that on Friday, August 21, David Wilson accepted the position of Chief of Operations. The Executive Director provided an overview of Mr. Wilson's background, noting that as a long time employee of the agency, his extensive knowledge of Tollway functions will be an asset to the agency. Mr. Wilson expressed his appreciation for the welcome.

Executive Director Bedalov announced that the Tollway is inviting high school art students to participate in the 2016 Tollway Map Cover Art Contest, this year's theme being "Save the Monarchs."

2015 Traffic Update: Executive Director Bedalov provided a summary of toll transaction results for the second quarter of 2015, highlighting that the current summer travel season has been the busiest in Tollway history. See attached presentation.

Director Johnson, referencing travel tips provided within the presentation, asked the reason that Fridays between 10 a.m. and 11 a.m. are an opportune time to begin weekend travel on the Tollway system. **Jonathon Hart, CDM Smith, responded that he** does not have the specific traffic data on hand but **will provide this information post-meeting.**

Managing Construction Changes and I-90 Progress: Executive Director Bedalov then introduced Paul Kovacs, Chief Engineer, to present an overview of the briefing previously provided the FAO Committee on how the Tollway manages construction changes and on the progress of construction on the eastern segment of the Jane Addams Memorial Tollway (I-90) Rebuilding and Widening Project. See attached presentation.

Committee Chair Gomez commended Mr. Kovacs and his staff for their work on the presentation, previously provided for the benefit of the FAO Committee.

Release of Retainage Policy: Executive Director Bedalov then re-introduced Mr. Kovacs to present an overview of the Tollway's release of retainage policy and to identify particular elements therein which may benefit from revision. <u>See attached presentation</u>.

Chairman Schillerstrom highlighted that in addition to retainage, performance bonds are also a requirement of Tollway construction contracts, providing the Tollway with further guarantees of satisfactory completion of projects by vendors. Chairman Schillerstrom then commented positively that the proposed modifications to the release of retainage policy would expedite payment of earnings to primes and consequently subcontractors, including disadvantaged business enterprises, to the benefit of all. He stated that the Board looks forward to receiving recommendations for retainage policy revisions, once fully developed by staff.

Quarterly Financial Review: Executive Director Bedalov then introduced Mike Colsch, Chief of Finance, to present the Quarterly Financial Review covering the preliminary budget to actual results for the second quarter ending June 30, 2015. See attached presentation.

Chairman Schillerstrom commented favorably on the results and congratulated Mr. Colsch and his staff for their work. He observed that an area which would likely benefit from reexamination is evasion recovery, suggesting that staff consider initiating an assessment of current practices to develop recommendations for additional efficiencies which might be achieved.

Items for Consideration

Chairman Schillerstrom, first reporting that normal committee structures are now back in place, clarified that each of following items for consideration has been reviewed in detail, discussed and approved by the FAO Committee, under the leadership of Committee Chair Gomez, for placement on the Meeting agenda with the Committee's recommendation.

<u>Item 3</u>: Extra Work Order on Contract I-13-4166 to Lorig Construction Company for Roadway & Bridge Reconstruction, on the Jane Addams Memorial Tollway (I-90) at Milepost 65.6 (Roselle Road), in the amount of \$308,250.00.

Director Banks made a motion for approval; seconded by Director Dotson. Chairman Schillerstrom asked if there were any questions, concerns or requests for discussion.

Director Gonzalez requested confirmation that change orders/extra work orders have been approved previously on this contract. Mr. Kovacs confirmed. He further responded that with offsetting positive adjustments expected to occur at the contract conclusion, the job, inclusive of costs for change orders/extra work orders, is still anticipated to be completed within budget.

Director Gonzalez inquired whether DBE goals on the underlying contract are amended to ensure that DBE subcontractors participate appropriately in change orders/extra work orders. Mr. Kovacs responded that vendors are expected to meet their DBE commitments as a percentage of the overall spend amount for the job, including any change orders/extra work orders authorized. David Goldberg, General Counsel, clarified that while DBE goals established for the original contract are not customarily modified by the Tollway, vendors are obligated to make good faith efforts to extend their DBE participation commitment levels to any supplemental work approved. He further explained that vendors which fail to do so would then be required to justify any shortfall to the Diversity department in order to be granted a waiver. Mr. Kovacs added that prior to receiving an authorization to proceed, vendors must specify the impact of change orders/extra work orders to overall DBE participation for the job. He further noted that the Board receives quarterly Capital Program Reports which detail final vendor performance in meeting Tollway contract requirements, including their Diversity Program commitments.

Director Gonzalez suggested that the agency might also evaluate the consequence to DBE subcontractors when scheduled completion dates are extended for primes to allow for completion of change orders/ extra work orders. Mr. Kovacs clarified that subcontractors are currently afforded recourse to seek from the Tollway compensable costs incurred as a result of Tollway schedule modifications.

Director Gomez asked what percentage of earnings held in retainage by the Tollway are owed by primes to their subcontractors. Mr. Kovacs responded that this information is not known to the agency, a concern that prompted the recently proposed policy revisions which would expedite releases of retainage.

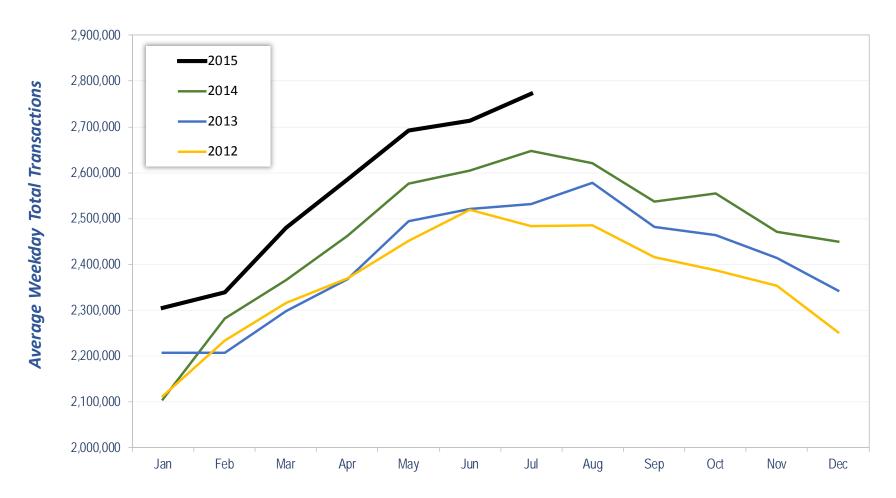

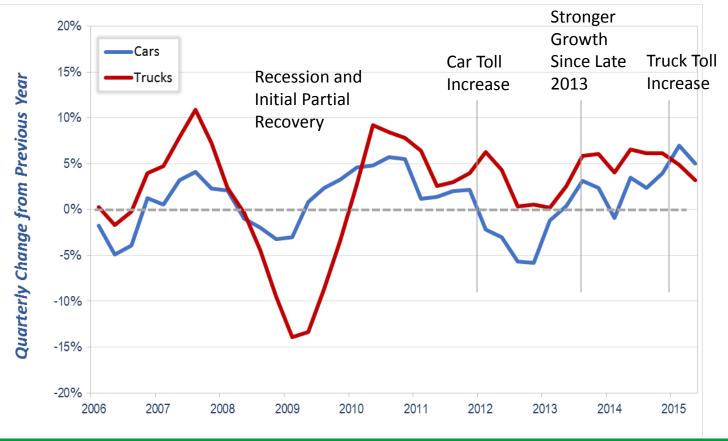

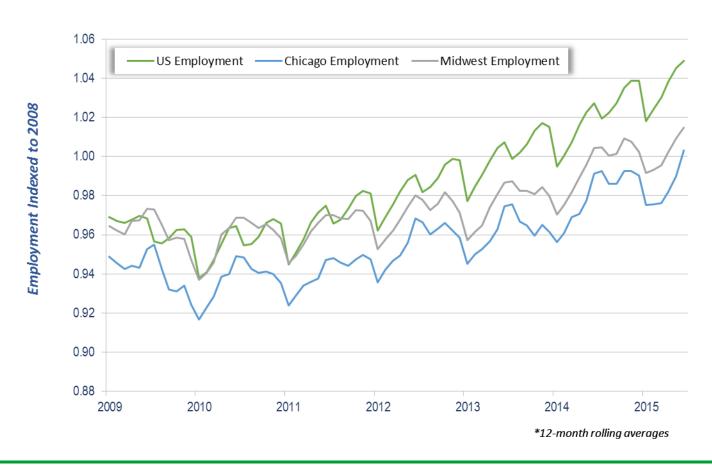

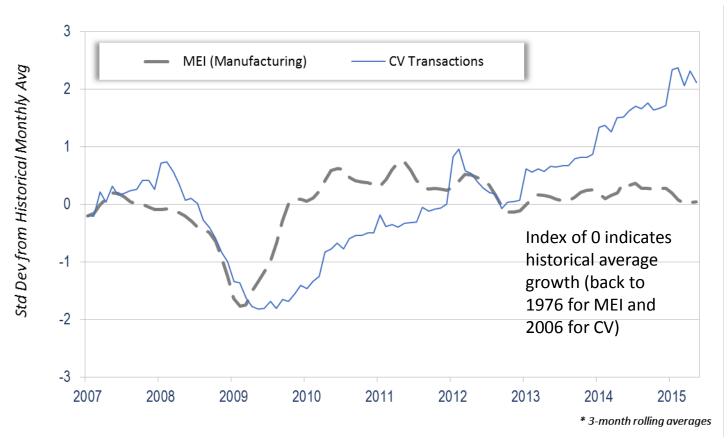
Chicago Metropolitan Statistical Area vs. Regional and National

Chicago Fed index that measures growth manufacturing business activity



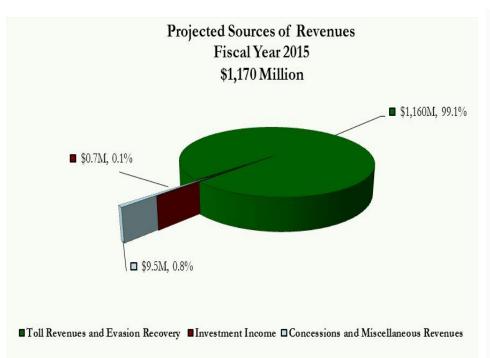


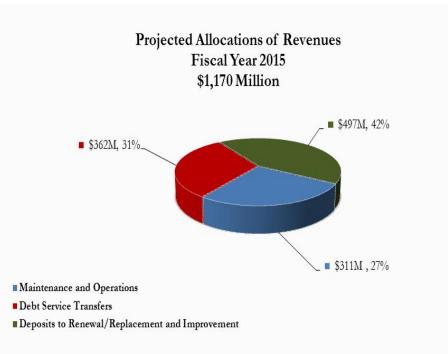

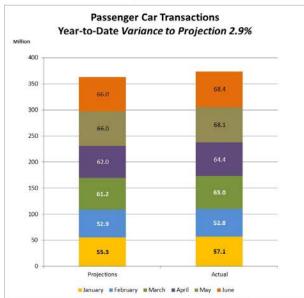

2015 vs. 2014 Transactions - Projections vs. Actual

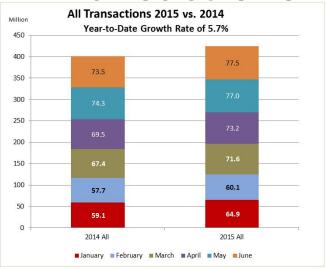


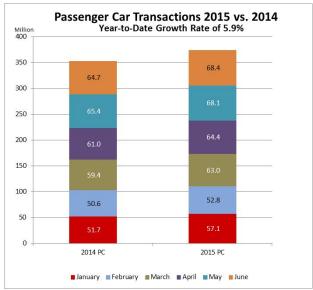


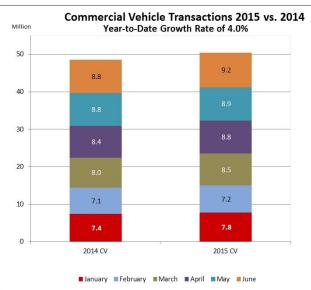




2015 vs. 2014 Transactions — Year-Over-Year

Managing Construction Changes and I-90 Progress

August 27, 2015

Change is Common



- Construction contract changes occur for a variety of reasons
 - Differing site conditions (unsuitable soil, unidentified utilities, etc.)
 - Specification changes
 - Schedule changes
 - Balancing for final field measurements
 - Errors and omissions
 - Miscellaneous (such as weather)
- Timely approvals are crucial to project delivery
 - Capital program investing about \$6 to \$8 million per day
- Details reported to the Board of Directors each month
- Illinois Tollway's change process is very effective
 - National average for highway construction is 5 to 10 percent compared to current Tollway capital program average of 0.4 percent*

- Contract Cost Change Controls Committee (C5)
 - Reviews and recommends construction contract changes
 - Reviewed by Chief Engineer (approve, reject, revise/resubmit)
 - Delegates signature authority per value of change
- Committee composition
 - Chairman appointed by the Chief Engineer
 - Two members appointed by the C5 Chairman (typically Tollway)

employees with design and/or construction experience)

- Committee meets daily during peak construction months
- Representatives from Finance,
 Procurement and Audit

Reputation for successfully delivering projects

- Delivered 80 percent of the 12-year Congestion-Relief Program in the first five years
 - Processed more than 14,000 change orders/extra work orders
 - Resulted in modified cost less than one percent of total award amount
- Successfully delivered 37-mile I-90 western segment
 - Opened on time despite initial delays ranging from 15 to 118 days
 - Implemented successful mitigation strategy
 - Resulted in 2.67 percent (\$15 million) below established budget

I-90 Eastern Segment Overview

- MOVE
- Rebuilding and widening 25 miles from six lanes to eight lanes
 - ▶ 28 bridges, including six interchanges
 - Urban region, with more than 270,000 vehicles per day
- Incorporating transit for the first time
- Implementing active traffic management (ATM) for the first time
- Addressing unique challenges throughout corridor







Initial delays had a ripple effect – from advance work contracts to current contracts

- U.S. Army Corps of Engineers permit delayed, required to begin work in regulated areas
- Major utilities serving more than 500,000 people run parallel to the corridor
 - Highly complex work
 - Restrictive work rules limit productivity
 - Utility firms have limited resources available
- Limited access to work zone
 - Delays in third party utility relocations
 - Delays obtaining right-of-way and required rights-of-entry
- Significant weather impacts



MOVE

Tollway is committed to delivering improvements on time and within budget

- Tollway is customer-focused
 - Minimizing impacts during construction
 - Making improvements in timely manner
- Developed consistent, yet individual solutions to include
 - Re-phasing and re-sequencing to prioritize mainline
 - Schedule recovery (extended hours/weekends)
 - Mobilization/remobilization
 - Extension of time for non-roadway work items
 - Winter protection for some work items

Quick Summary



- I-90 change orders and extra work orders are within budget
 - ▶ 2015 budget for I-90 is \$839.6 million
 - Cost of mitigation plans for I-90 are 1.9 percent of the 2015 budget
 - Operating within the \$2.5 billion I-90 Rebuilding and Widening Project budget
- To date, capital program change orders/extra work orders account for 0.4 percent of total contract awards



Release of Retainage

Rules of Retainage



- Required by the Tollway's Trust Indenture and specifications
- Retainage requirements
 - Ten percent of each payment amount retained until project is 50 percent complete
 - Upon completion of 50 percent of the work, retainage can be reduced with the Chief Engineer's approval
 - Partial release of retainage less than 5 percent requires Board approval
 - Final release of retainage requires Board approval
- Detailed review process prior to Board approval
- Ensures contract compliance and completion by the contractor
- Diversity goals must be addressed prior to final payment
- Evaluating modifications to expedite the process





Contract award for \$10 million

Award

- 10 percent of each payment is retained until the work is 50 percent complete
- At 50 percent complete (\$5 million), \$500,000 has been retained

50%

- Once 50 percent complete, contractor may request no additional retainage be withheld on subsequent payments
- Chief Engineer approval is required

Partial

- Towards the end of the contract, \$100,000 of work remains
- Contractor may request partial release withheld; minimum retainage of \$100,000 x 2 = \$200,000
- Board approval required to release \$300,000 of retainage

Final

- All work is completed, reviewed and deemed acceptable
- Board approval required to release \$200,000 remaining retainage

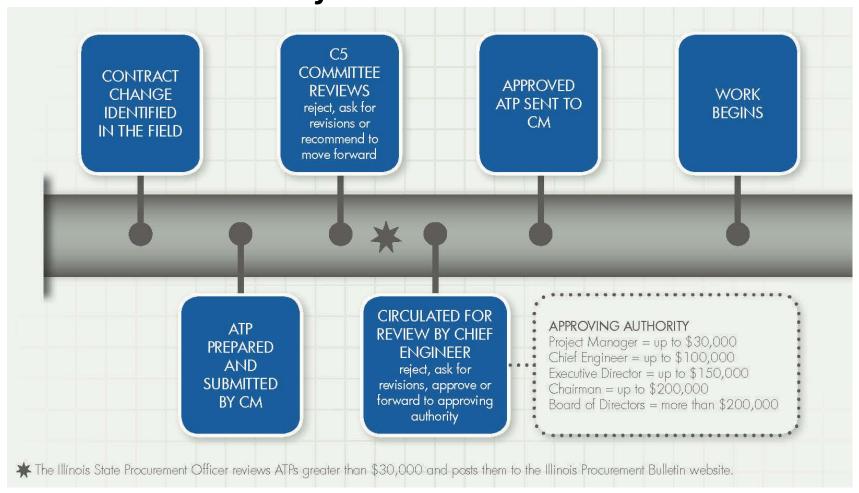
