Subject to approval by the Tollway's Board of Directors, the Illinois Tollway is giving notice of intent to renew the contract 11-0017 Liability Insurance Program with USI Midwest for Liability Insurance Program. This procurement will provide general liability coverage, business automobile liability coverage and excess liability coverage. It protects the operations of the Agency and any legal action against the agency for injuries or damage to property related to its properties or operations, which cannot be heard in the State's Court of Claims.

This contract is a result of an RFP originally awarded pursuant to solicitation Reference# 22021067 with a one year initial term and four one-year renewal options. The Tollway will execute the third renewal option.

There was no BEP goal on the initial contract or first renewal; however, there is a 3.5% commitment on this renewal.
