THE ILLINOIS STATE TOLL HIGHWAY AUTHORITY MINUTES OF THE REGULAR BOARD MEETING

February 27, 2014

The Illinois State Toll Highway Authority met in regular session on Thursday, February 27, 2014, at approximately 9:00 a.m. in the Board Room of the Illinois State Toll Highway Authority's Central Administration Building, in Downers Grove, Illinois. The Meeting was held pursuant to By-Laws of the Authority upon call and notice of the Meeting executed by Chair Paula Wolff and posted in accordance with the requirements of the Open Meetings Act.

Bolded entries indicate issues which will require follow-up to present to the Board.

PUBLIC COMMENT

Chair Wolff called for public comment. No public comment was received.

CHAIR'S ITEMS

Chair Wolff called for a motion to approve the minutes of the Board Meeting held on January 23, 2014. Director Peterson made a motion to approve; seconded by Director Weisner. The motion was approved unanimously.

STANDING COMMITTEE REPORTS

Finance, Operations, and Administration Committee

Director Peterson reported on the February 19, 2014 meeting of the Finance, Administration and Operations Committee (FAO).

FINANCE presented two items which were approved by the FAO Committee. The first item is payment of the Tollway's share of 2013 retiree health insurance costs to the Department of Central Management Services (CMS). The second item is an increase in the contract with Vantiv to process merchant card transactions.

PROCUREMENT presented four items which were approved by the FAO Committee. Three were awards based on competitive selection and the fourth is an emergency extension of an existing contract with Meade to purchase Traffic and Security Monitoring and Management System Maintenance (TIMS) to allow time to complete a competitive bidding process.

ENGINEERING presented 34 engineering items which were approved for the consent agenda. A summary of the items were:

- 15 new construction contract awards, representing approximately \$250 million in improvements
- 1 new professional services contract
- 1 request for proposal
- 1 supplement on a design contract
- 2 change orders and 1 extra work order on construction contracts
- 3 requests for partial release of retainage on construction contracts
- 7 requests for final release of retainage on construction contracts, and
- 3 land acquisition items.

LEGAL presented five items which were approved for the consent agenda. Four items are intergovernmental agreements (IGA). The fifth item is a worker's compensation settlement, which was discussed in detail during the FAO Committee Executive Session. The items approved were:

- 1. **IGA** with the Illinois Department of Transportation (IDOT) Pursuant to long-standing arrangements with IDOT, as part of the Congestion Relief Plan, the Tollway agreed to perform extra work on the I-294 northbound bridge over Illinois Route 21 (Milwaukee Ave.) to accommodate IDOT's request for that bridge to be lengthened and positioned in a way to more easily allow future widening of Route 21.
- 2. **IGA** with **IDOT**, this IGA relates to the southbound bridge carrying 294 over Rte. 21.
- 3. **IGA** with the Village of Rosemont In this IGA, which addresses bridge reconstruction work on I-90 at various points, Rosemont is committing to maintaining the underpass lighting on the bridge carrying I-90 over Des Plaines River Road.
- 4. **IGA** with **IDOT** and the Village of Hoffman Estates In connection with the Tollway's construction of a full access interchange on I-90 at Barrington Road, in this IGA the three parties are establishing their cost-sharing for the project.
- 5. Workers Compensation Settlement –The amount authorized for settlement purposes is as discussed by the FAO Committee in Executive Session.

Strategic Planning Committee

Director Weisner reported on the February 19, 2014 Strategic Planning Committee meeting.

Two primary topics were discussed at the Strategic Planning Committee, the 2014 and 2015 work plan and the I-90 Corridor vision.

2014 will focus on advancing strategies and assessing effectiveness of past efforts. Specifically the work plan for 2014 will include:

- I-90 Active Traffic Management
- The Tollway role in other regional tolling projects
- Revisiting the progress of Tollway "green" construction initiatives and environmental rating system for Tollway construction projects
- An update on the Illinois Route 53/Route 120 project
- A joint Strategic Planning Committee and Customer Service Committee meeting is to be held mid-year to discuss tolling business rules and policies
- An update on the Tollway Freight Planning effort and
- A discussion of the recommendations are from the Illinois 53/Route 120 Finance Committee, which will also lead into a discussion of potential other innovative financing and tolling options.

Regarding the I-90 corridor, a presentation regarding Active Traffic Management on a portion of the corridor was made to the Committee. The Committee recommended the Tollway move forward with Active Traffic Management on the designated portions of the I-90 corridor. A portion of the Committee presentation will be presented to the Board.

In addition, the Committee discussed the Tollway coordinating with the Illinois Department of Transportation on advancing legislation creating a pilot design-build program. The intent is to move a limited number of projects using a design-build model.

EXECUTIVE DIRECTOR

Special Meetings

Executive Director Kristi Lafleur informed the Board that, given the level anticipated of capital projects, "special meetings" may be

scheduled to keep the Tollway capital program on schedule. These meetings will follow Open Meetings Act rules as all other Board meetings, but will provide flexibility so contracts can be considered and approved in a timely manner.

Chair Wolff asked to confirm that any additional meetings would be scheduled in such a way as to provide timely notice to the public and to members of the Board, and would be compliant with the Illinois Open Meetings Act. Executive Director Lafleur confirmed that timely notice would be provided and would follow the requirements of the Open Meetings Act.

House Public Safety Committee Meeting

Executive Director Lafleur informed the Board she participated in a hearing of the House Appropriations-Public Safety Committee with Transportation Secretary Ann Schneider and Illinois State Police Director Hiram Grau to discuss efforts to improve traffic safety for drivers and for employees of all three agencies.

The committee was informed that a group consisting of representatives of all three agencies already has met several times to discuss efforts that can be taken together to promote traffic safety. That working group will continue meeting over the next several months to offer recommendations for steps that could be taken to make our roads safer.

The committee was also updated on the recent "Drop It and Drive" campaign to educate drivers about the new law banning hand-held cell phone use as a way of discouraging distracted driving.

The committee invited the heads of all three agencies to return in the future to discuss any recommendations made by the working group and the steps being taken by the Illinois Tollway, Illinois Department of Transportation and Illinois State Police to implement those recommendations.

Illinois State Police Captain Kimes

Executive Director Lafleur then introduced Captain Patrick Kimes, who was recently assigned to serve as the Commander of Illinois State Police District 15.

Executive Director Lafleur thanked Illinois State Police Lieutenant Bob Meeder, who served as acting commander of District 15 since September of 2013.

Captain Kimes then provided an update to the Board on the condition of Trooper Douglas Balder, who was seriously injured in an incident that occurred earlier this year on the Reagan Memorial Tollway (I-88).

Vincent Petrella Memorial

Executive Director Lafleur introduced Diana Stewart, Senior Manager of Marketing and Communications, to update the Board on a planned memorial for Tollway worker Vincent Petrella, who was killed in the line of duty on January 21, 2014. Ms. Stewart provided a presentation to the Board on the memorial. See attached presentation.

Active Traffic Management on I-90

Executive Director Lafleur updated the Board on plans to introduce Active Traffic Management as part of the Jane Addams Memorial Tollway (I-90) Rebuilding and Widening Project and stated the Tollway's goal is to transform I-90 into a 21st century, state-of-the-art corridor that incorporates the latest technologies – "smart" features that will make the roadway safer and more efficient for Tollway customers.

Chief Engineer Paul Kovacs presented a video demonstration of the potential Active Traffic Management upgrades.

I-90 Water Main Relocation – P. Foernssler

Executive Director Lafleur introduced Pete Foernssler, Deputy Chief of Engineering for Program Implementation, to update the Board on the status of plans to relocate this water main to accommodate the I-90 Rebuilding and Widening Project. See attached presentation.

Chair Wolff wished to make certain that, utilizing the process Mr. Foernssler described, consumers of water supplies of this main will not notice any change in their water supply during the work. Mr. Foernssler stated that consumers will notice no disruption in their water supply.

Chair Wolff then noted that currently only one company is able to perform the work described, and asked if the work would be able to be performed on schedule. Mr. Kovacs stated that the process to execute the work was currently proceeding on schedule and that the Engineering Department and Procurement Department were working together to coordinate the contracting process, so as to bring contracts to the Board in a timely fashion. Mr. Kovacs further stated that the priority for such work would be to preserve uninterrupted water service to consumers.

Consent Agenda

Chair Wolff reminded the Board and guests that items on the Consent Agenda were previously reviewed in detail in Committee.

 - Elk Grove Village, Schaumburg, Rolling Meadows, Hoffman Estates, Hanover Park, Streamwood and Mount Prospect
- Service to a daytime population of 500,000 people totaling 12 billion gallons a year
- Pipe installed by agreement with the Tollway in 1984
 - Adjacent to Tollway for approximately 16.5 miles
 - 90" to 20" transmission mains, up to 150 psi

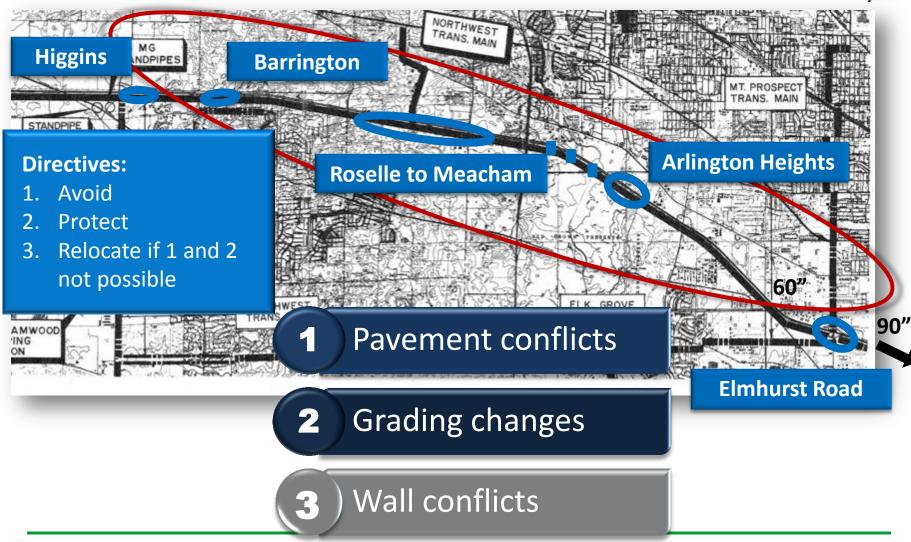






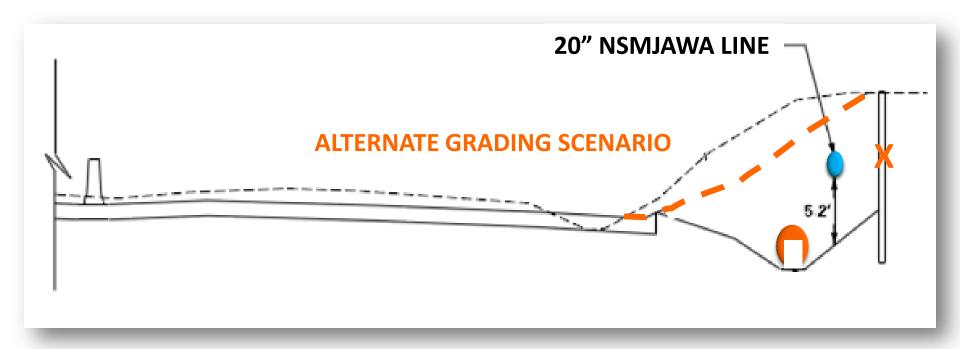

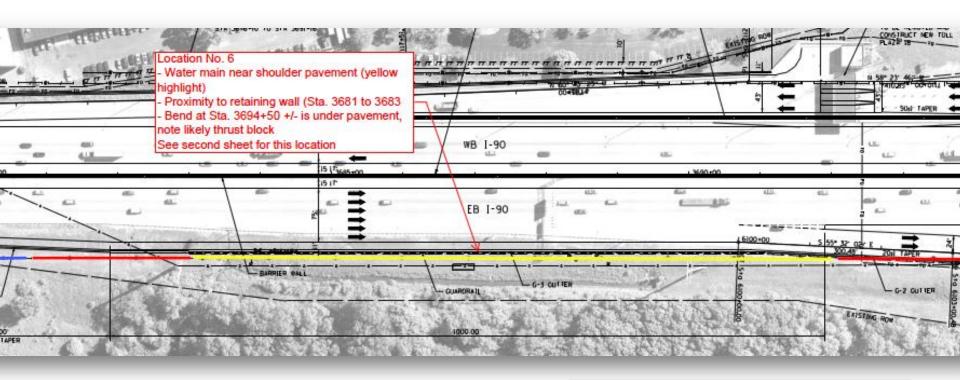

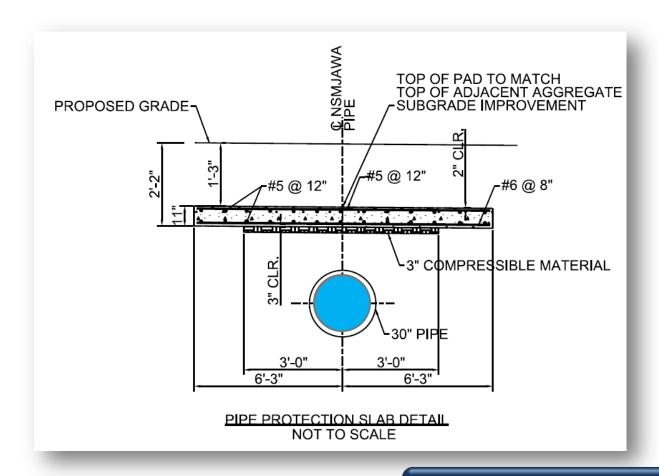

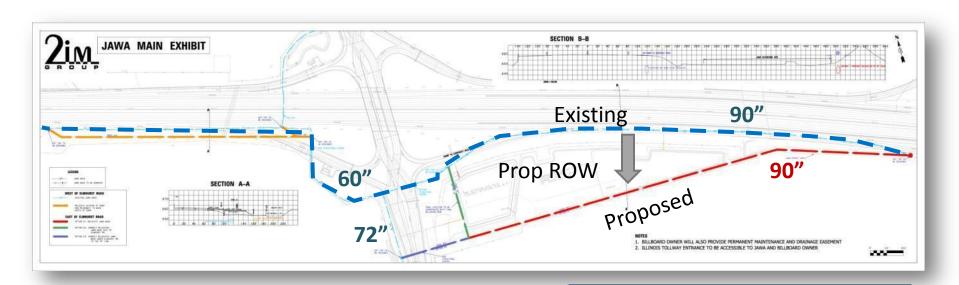

What is a hot tap?

A hot tap makes a connection to existing piping without the interrupting or emptying that section of pipe

Why use a hot tap?

- Total shutdown is not an option no disruption of service
- Temporary bypass piping is used to maintain water service
- Performed when water usage is lowest
- Lowest amount of risk
