Committee Chairman Andalcio called for a voice vote, and there being "Ayes" and no "Nays", declared the motion carried.

Committee Chairman Andalcio called on the Chief of Engineering to present his Agenda. Mr. Paul Kovacs requested approval of the Award of Contract RR-09-5577 to IHC Construction Companies, LLC for Culvert Repairs, Systemwide, in the amount of \$2,888,065.80.

Committee Chairman Andalcio called for a motion approving said Award for the Consent Agenda.

Director Roolf moved for approval; seconded by Director Towns.

Committee Chairman Andalcio called for a voice vote, and there being "Ayes" and no "Nays", declared the motion carried.

Mr. Kovacs then stated that the Award of Contract RR-09-5579 was being pulled from the Agenda.

Mr. Kovacs then requested approval of the Final Release of Retainage on Contract I-07-5246 to Kenny Construction Company for Bridge Reconstruction and Roadway Resurfacing and Widening on the Tri-State Tollway (I-294) at Milepost 52.9 (Lake-Cook Road), in the amount of \$270,000.

Committee Chairman Andalcio called for a motion approving said Final Release for the Consent Agenda.

Director Canham moved for approval; seconded by Director Towns.

Committee Chairman Andalcio called for a voice vote, and there being "Ayes" and no "Nays", declared the motion carried. Director Roolf abstained from voting on Contract I-07-5246.

Mr. Kovacs then requested approval of the following:

Final Release of Retainage on Contract I-08-5494 to Lorig Construction Company for Reconstruction and Widening on the Reagan Memorial Tollway (I-88) from Westbound Milepost 131.9 (Finley Road) to Milepost 137.0 (IL Route 83), in the amount of \$240,000.

Final Release of Retainage on Contract I-06-5807 to Walsh Construction Company of Illinois/K-Five Construction Corporation (JV) for Roadway and Bridge Reconstruction and Widening on the Westbound Reagan Memorial Tollway (I-88) from Milepost 128.3 (Naperville Road) to Milepost 131.7 (Finley Road), in the amount of \$961,716.29.

Committee Chairman Andalcio called for a motion approving said Releases for the Consent Agenda.

Director Towns moved for approval; seconded by Director Roolf.

Committee Chairman Andalcio called for a voice vote, and there being "Ayes" and no "Nays", declared the motion carried.

Mr. Kovacs then requested approval of the following:

Permit NW 09-12 to Kentucky Data Link, Inc. for permission to install, maintain and operate fiber optic cable facilities under I-90 at Plum Grove Road. Fee will be \$1,000.

Permit TS 09-09 to the Village of Glenview for permission to install, maintain and operate an 8" water main inside a 24" steel casing by pipe ramming under I-294 at Oak Trail Road. Fee is not required.

Permit TS 09-11 to Commonwealth Edison Company for permission to install, maintain and operate an underground electric line installed in conduit under and across I-94 at Washington Street. Fee is not required.

Committee Chairman Andalcio called for a motion approving said Permits for the Consent Agenda.

Director Canham moved for approval; seconded by Director Towns.

Committee Chairman Andalcio called for a voice vote, and there being "Ayes" and no "Nays", declared the motion carried.
