Chairman Mitola then called for a motion to approve the Minutes of the Board Meeting held on May 25, 2006. Director Roolf moved for approval; seconded by Director Pradel.

Chairman Mitola called for a voice vote, and there being "Ayes" and no "Nays", declared the motion carried.

Chairman Mitola then called on the Acting Executive Director. Mr. Brian McPartlin thanked Director Roolf for his leadership on the 355 Interchange Policy and for attending the meetings with the individual municipalities.
