They noted that it was not just Will County but the whole region. All of the governmental officials in Will County endorsed the resolution that was passed."

There being no further business, Chairman Mitola called for a motion to adjourn. Director Moore moved to adjourn; seconded by Director Andalcio.

Chairman Mitola called for a voice vote, and there being "Ayes" and no "Nays", declared the motion carried.
