MINUTES OF THE REGULAR MEETING OF THE ILLINOIS STATE TOLL HIGHWAY AUTHORITY

December 18, 2008

The Illinois State Toll Highway Authority met in regular session on Thursday, December 18, 2008 at approximately 10:40 a.m. in the Board Room of The Illinois State Toll Highway Authority's Administration Building in Downers Grove, Illinois.

Chairman Mitola stated that this is the regularly scheduled meeting of the Board of The Illinois State Toll Highway Authority and asked the Secretary to call the roll. Those present and absent were as follows:

Chairman Mitola stated that individuals were present who wanted to speak during the Public Comment section of the Agenda. He then called on Mr. Dennis Twohig who stated that he would like the Governor's name removed from the signs over the ORT lanes.

Chairman Mitola then called on Ms. Lynn Stevens who briefed the Board on problems she has had with violations.

Chairman Mitola then called on Mr. Peter Arendovich. Mr. Arendovich lives at 135th and I-355 and would like noise decibel levels taken at his house.

Chairman Mitola instructed Mr. Rocco Zucchero to give a report on this situation at the next Board Meeting.

Chairman Mitola then called on Ms. Mary Kramer from the Regional Transportation Authority. Ms. Kramer told the Board that the RTA was in favor of Phase II of the Congestion Relief Plan.

Chairman Mitola then called on Mr. Donald Schaefer from the Mid-West Truckers Association. Mr. Schaefer stated that the Association wants the Board to rescind approval of Phase II of the capital plan and associated toll rate increases on truckers.

Chairman Mitola then continued with the Agenda and called for a motion approving the Minutes of the Regular Board Meeting held on November 20, 2008. Director Towns moved for approval; seconded by Director Moore.

Chairman Mitola called for a voice vote, and there being "Ayes" and no "Nays", declared the motion carried.

Chairman Mitola then called for a motion approving the 2009 Meeting Schedule and the 2009 Holiday Schedule. Director Towns moved for approval; seconded by Director Pradel.

Chairman Mitola called for a voice vote, and there being "Ayes" and no "Nays", declared the motion carried.

Chairman Mitola then stated, "Jeff Dailey submitted his resignation to me yesterday. He was concerned about constraints put on the Executive Director to work in their respective fields."

Chairman Mitola called for a motion adopting a resolution appointing Dawn Catuara as Acting Executive Director. Director Andalcio moved for adoption; seconded by Director Moore. This appears in the Appendage as Resolution No. 18551.

Chairman Mitola called for a voice vote, and there being "Ayes" and no "Nays", declared the motion carried.

Chairman Mitola then discussed Phase II of the Congestion Relief Plan. He stated that he has a strong belief in the need for this Interchange Improvement Program and congestion relief green lanes. He thanked everyone for their support affirming these investments and for the needs of the future.

Chairman Mitola then reviewed the timeline of the meetings and hearings of the planning group for Phase II over the past 21 months which was distributed to the Board.

The Board then discussed various aspects of the Phase II Capital Plan. The Chairman indicated that the Tollway would continue with planning work but would not implement any new plans until the Tollway had a new Executive Director and the Inspector General would conduct a review of the development of Phase II.
