# Why is the State interested in Small Businesses?

- You will create the majority of new jobs in the coming years.
- Small business health promotes capital investment and business expansion.
- The Chief Procurement Office ensures that small businesses have the maximum practicable opportunity to provide goods and services to the State.

# Why is the State interested in Small Business?

- Small Business Contracts Act P.A. 97-307 Effective August 2011
- Goal that not less than 10% of state contracts go to Illinois' small businesses
- \$7.4 billion awarded contracts in FY' 11
- 35,000 contracts awarded to small businesses
- \$193 million spent with small business in FY' 11 (2.6%)
- Agencies and universities develop strategies and submit annual compliance plans
- CPOs develop strategies and report progress to the General Assembly

## VENDOR REGISTRATION

## STEP 1: Register to receive Procurement Bulletins

Register to electronically receive email notifications and download postings from the Illinois Procurement Bulletin (IPB) and the Higher Education Procurement Bulletin (HEPB). Although registration with both bulletins is not necessary to browse the site, registration is required to download solicitations and to receive email notifications for all new solicitations, addendums, and award notices.

## STEP 2: Apply for Small and Diverse Business Programs

To enroll in the Small Business Set-Aside Program (SBSP) and/or to apply for the Business Enterprise Program (BEP)complete the following forms. You can participate in both programs if you meet each program's requirements. Businesses must complete the Small and Diverse Business Application.

- Small & Diverse Business Application Form (a dual form)
  - This list of <u>commodities classifications/services codes</u> will help you to identify the proper supply commodity/service codes needed to complete #9 on Page 4 of the Small & Diverse Business Application Form.
- REQUIRED: <u>Federal Taxpayer ID number W-9 Form</u>
- REQUIRED if you are LLC or Corporation Business you must be in good standing with the Secretary of State of Illinois for more details call (217) 782-6961.
- REQUIRED: If you have 15+ Employees: <u>Illinois Department of Human Rights (IDHR) Employer</u>
  <u>Report Form</u> to be submitted to IDHR address listed on form.

NOTE: You must obtain an IDHR number prior to submitting a Small & Diverse Business Application Form if applicable to your company.

# **SBSP Application FAQ's**

- Is the application the only thing the applicant needs to fill-out and send in?
  - IL Dept. of Human Rights Contractor #
  - Tax return
- Can a small business in Indiana win a SBSP contract?
  - Out of State vendors are not eligible for SBSP
- How long will it take for the application to be approved?
  - Currently, it takes about seven to ten days
- How long will my small business eligibility be effective?
  - Small business eligibility will last three years
