### Description and Specifications:

The Illinois Tollway is giving notice of intent to amend its contract with Pillar Equipment, Inc. and Buck Brothers Inc. The amendment is to cancel Line 2 and Line 6 from Pillar Equipment, Inc. and to award to the next responsible and responsive bidder Buck Brothers Inc.

Pillar Equipment is unable to meet contract specifications for these two pieces of equipment listed below.

Line 2 Front and Rear Wheel Drive 145 HP Large Tractor (No Mower)

Line 6 Front Mounted Mower with Cab according to the specifications provided by the Tollway as part of the contract.
