Brooks asked if there are any questions, concerns or requests for amendment. Hearing nothing, Committee Chair Brooks called for a vote. The motion was PASSED unanimously.

Executive Director's Items

Illinois Tollway Diversity Initiatives Update: Executive Director Bedalov introduced Gustavo Giraldo, Chief of Diversity and Strategic Development, to provide an update for the Committee on the Tollway's diversity initiatives. <u>See attached presentation</u>.

Upon conclusion of the presentation, Director Gomez asked if the funding of technical assistance programs is believed responsible for an increase in the number of minority firms being awarded Small Business Set Aside contracts. Mr. Giraldo responded affirmatively.


Director Gomez further inquired about measurable goals and expected outcomes of the technical assistance programs. Mr. Giraldo responded that the Tollway has performance measures articulated within the contracts for the Workforce Technical Assistance Programs to assess the effectiveness of providers, ensuring accountability and value received for Tollway resources. He further responded that meaningful data should be available late 2017 or early 2018.

Director Dotson also expressed his interest in data on the effectiveness of the technical assistance programs. He suggested that underserved areas may need additional targeting and commended Tollway staff on their efforts to date.

Director Gomez inquired about the participation of key stakeholders, in particular Illinois unions and road builders, and emphasized the importance of their participation. Mr. Giraldo responded that the Tollway has met with unions and had several meetings with the Equal Opportunity / DBE Committee of the Illinois Road & Transportation Builders Association to ensure the framework of the Partnering 4 Growth (P4G) program is embraced by the industry as its implementation is finalized. He highlighted that the industry has expressed strong interest in participating in the P4G program.

Upon conclusion of the discussion, Committee Chair Brooks stated that the Committee would next meet in December. He further announced the Diversity & Inclusion Committee will meet on a quarterly basis in 2018.

There being no further business before the Committee, Committee Chair Brooks requested a motion to adjourn. Motion to adjourn was made by Director Gomez; seconded by Director Gonzalez. Committee Chair Brooks then called for a vote. The motion was PASSED unanimously.


Contractor Diversity

Studying appropriate substitute for IDOT pregualification on contracts under \$5 million

- IDOT pregual is participation barrier for small and diverse firms due to time and expense
- Pregualification is unnecessary at lower contract amounts
- Tollway performance bond requirement is accurate measure of contractor ability to perform work
- Require "similar work experience" document at time of bid
- Reviewed by Engineering, Legal and Risk Management
- Will not impact project safety
