## ANNIE GLIDDEN ROAD INTERCHANGE RECONSTRUCTION BEGINS NEXT WEEK ON THE REAGAN MEMORIAL TOLLWAY (I-88) IN DEKALB

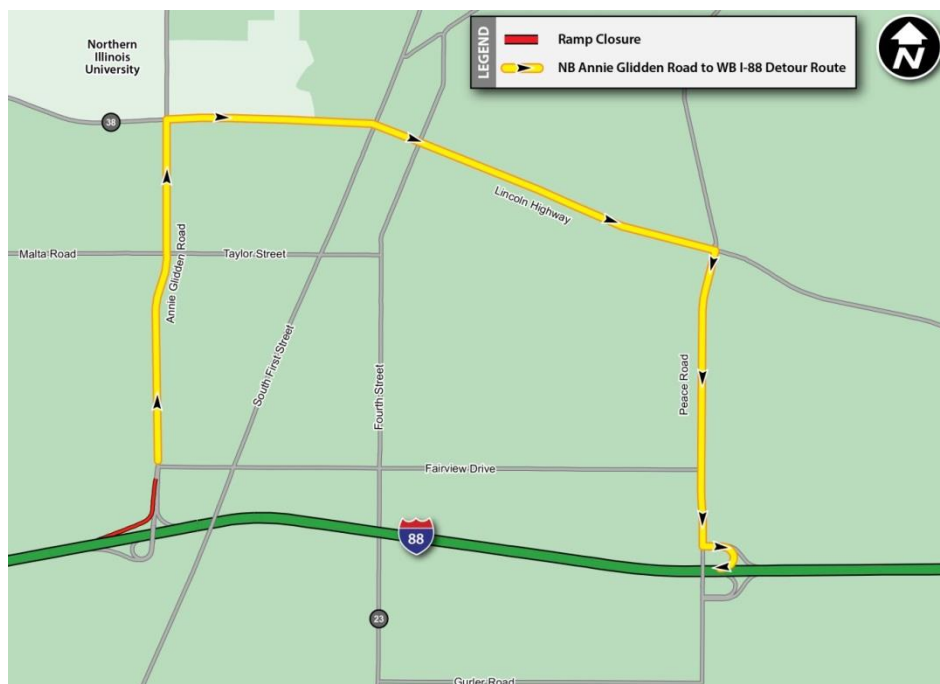
*Ramp closure and detours scheduled through summer to complete work*

**DOWNERS GROVE, IL** – The Illinois Tollway is scheduled to begin reconstruction work at Annie Glidden Road Interchange next week with the closure of the ramp connecting Annie Glidden Road to westbound I-88. Electronic message signs and construction signage will be put in place to alert drivers to scheduled closures and detours.

The Illinois Tollway has scheduled work to resurface and rebuild ramps and bridges at six interchanges on I-88 between Illinois Route 251 and Orchard Road. At the Annie Glidden Road Interchange, all four ramps connecting I-88 to Annie Glidden Road are scheduled to be rebuilt. Bridge deck repairs are also scheduled on the ramp bridge connecting Annie Glidden Road and eastbound I-88. Lighting improvements are also planned.

Weather permitting, on Monday, April 2, the ramp connecting Annie Glidden Road to westbound I-88 is scheduled to close for six weeks. A detour will be posted directing traffic to use Lincoln Highway (Illinois Route 38) and the Peace Road Interchange to access I-88.



Once the work at the westbound I-88 entrance ramp is complete in May, the other three ramps at the interchange are scheduled to close simultaneously with traffic once again routed to the Peace Road Interchange. All work at the interchange is scheduled to be completed by the end of summer.

Ramp and bridge closures and detours will allow the Tollway to safely accommodate construction and will allow the work to be completed in half the time. Work will be staggered so that adjacent interchanges are not under construction at the same time.

In addition, throughout 2018 traffic on I-88 in this area will be reduced from two lanes to one in each direction for a roadway resurfacing project. The shoulders on this segment of I-88 are too narrow to safely accommodate traffic shifts and provide for work zones.

The improvements on I-88 will extend the life of the roadway and interchanges improving travel in the area and providing convenient access to local communities and support economic opportunities. This work is part of the Tollway's 15-year, \$14 billion capital program, *Move Illinois: The Illinois Tollway Driving the Future*.

Construction is being coordinated with the Illinois Department of Transportation, City of DeKalb, DeKalb County, Kane County, Ogle County, Dement Township, Malta Township, DeKalb Township, City of Rochelle, Pierce Township, Kaneville Township, Village of Sugar Grove and Cortland Township, as well as local fire and police departments and Northern Illinois University.

### **Work Zone Safety**

The Illinois Tollway is committed to ensuring that the Reagan Memorial Tollway (I-88) and other area roadways remain safe for both drivers and workers during construction, which is part of the agency's overall commitment to roadway safety.

Construction zone speed limits are in effect in all construction zones 24/7 and drivers should continue to watch for changing traffic patterns and use caution, especially when workers are present. On I-88, a 45 mph work zone speed limit is in effect throughout the construction season.

The Illinois Tollway reminds motorists that the "Move Over Law" requires motorists to change lanes or to slow down and proceed with caution when passing any vehicle on the side of the road with hazard lights activated. If you see flashing lights ahead, please move over or slow down.

Illinois State Police have zero tolerance for drivers speeding in work zones or failure to comply with the Move Over Law.

The minimum penalty for speeding in a work zone is \$375. Posted signs advise drivers of a \$10,000 fine and a 14-year jail sentence for hitting a roadway worker.

Penalties for failure to slow down or move over for a vehicle on the shoulder with flashing lights includes up to a \$10,000 fine, 2-year suspension of driving privileges and jail time, in extreme cases.
