NIGHTLY RAMP CLOSURES SCHEDULED NEXT WEEK FOR DEERFIELD ROAD ON NORTH TRI-STATE TOLLWAY (I-94)

Overnight closures with detour scheduled on westbound I-94 exit ramp to Deerfield Road for ramp paving work

DOWNERS GROVE, IL – Temporary ramp closures with posted detours are scheduled to begin next week at the Deerfield Road Interchange on the North Tri-State Tollway (I-94) for asphalt paving as part of ongoing roadway repair work. Electronic message signs and construction signage are in place in advance to alert drivers.

"The Illinois Tollway understands safety is just as important as access for drivers who use the Tollway to reach work and home, and we thank them for their patience," said Illinois Tollway Executive Director José Alvarez. "Closing the Deerfield Road ramp allows us to safely complete this work in less time and minimize the inconvenience to customers."

Weather permitting, beginning Monday, September 9, and continuing through Thursday, September 12, nightly closures are scheduled to start at 7 p.m. on the ramp connecting westbound I-94 to Deerfield Road. A detour will be posted directing traffic to exit at Half Day Road and travel west to southbound Milwaukee Road to access Deerfield Road. The ramp will reopen each morning by 5 a.m. in advance of the morning rush hour.



Additional ramp overnight, weekend ramp closures with detours will be scheduled later this year on the ramps connecting Deerfield Road to eastbound I-94 and eastbound I-94 to Lake Cook Road for repair and resurfacing work. Only one ramp will be closed at a time.

The work is being coordinated with the Illinois Department of Transportation, Lake County, Cook County, as well as local municipalities, fire and police departments. Up to 160,000 vehicles use segments of I-94 daily.

In 2019, work is scheduled between Half Day Road and the Edens Spur and includes mainline, shoulder and ramp pavement patching and overlays. Construction will also include drainage improvements, noisewall and retaining wall repairs. Roadway lighting work is scheduled along the mainline between the Edens Spur and Duffy Lane. The repair work is scheduled to be complete by the end of the year.

These repairs are necessary to extend the life of the roadway and provide safe and convenient travel for Tollway customers. This work is part of the Tollway's 15-year, \$14 billion capital program, *Move Illinois: The Illinois Tollway Driving the Future.*

Work Zone Safety

Construction work zone speed limits are in effect in all construction zones 24/7. On I-94, a 45 mph work zone speed limit is in effect throughout the construction season.

The Illinois Tollway reminds motorists that the "Move Over Law" requires motorists to change lanes or to slow down and proceed with caution when passing any vehicle on the side of the road with hazard lights activated. If you see flashing lights ahead, please move over or slow down.

Illinois State Police have zero tolerance for drivers speeding in work zones or failure to comply with the Move Over Law.

The minimum penalty for speeding in a work zone is \$250. Posted signs advise drivers of a \$10,000 fine and a 14-year jail sentence for hitting a roadway worker.

Penalties for failure to slow down or move over for a vehicle on the shoulder with flashing lights includes up to a \$10,000 fine, 2-year suspension of driving privileges and jail time, in extreme cases.

The Illinois Tollway's 15-year, \$14 billion capital program, *Move Illinois: The Illinois Tollway Driving the Future*, is improving mobility, relieving congestion, reducing pollution, creating as many as 120,000 jobs and linking economies throughout the region. The Illinois Tollway is a user-fee system that receives no state or federal funds for maintenance and operations. The agency maintains and operates 294 miles of roadways in 12 counties in Northern Illinois, including the Reagan Memorial Tollway (I-88), the Veterans Memorial Tollway (I-355), the Jane

Addams Memorial Tollway (I-90), the Tri-State Tollway (I-94/I-294/I-80) and the Illinois Route 390 Tollway.
