## RAMPS, BRIDGE TO REOPEN AT 159<sup>TH</sup> STREET INTERCHANGE ON TRI-STATE TOLLWAY (I-294) IN MARKHAM

Interchange improvements provide for improved travel for drivers

**DOWNERS GROVE, IL** – The Illinois Tollway is nearing completion of the 159<sup>th</sup> Street Interchange Project on the Tri-State Tollway (I-294) in Markham and will reopen ramps and restore bridge traffic this week.

"The Illinois Tollway understands safety is just as important as access for drivers who use the Tollway to reach work and home, and we thank them for their patience throughout this construction project," said Illinois Tollway Executive Director José Alvarez. "Closing lanes and shifting traffic allowed us to safely complete this work and deliver improvements that will benefit the community and our customers."

Weather permitting, on Thursday, July 11, traffic on the 159<sup>th</sup> Street Bridge over I-294 will be returned to its normal configuration and the ramps carrying traffic from westbound 159<sup>th</sup> Street to southbound I-294 and from northbound I-294 to westbound 159<sup>th</sup> Street are also scheduled to reopen.

As the Tollway works to wrap up the two-year construction project, shoulder closures on I-294 and lane reductions on the collector-distributor lanes for the ramps will continue through the end of the month as remaining work on this contract which includes signing, striping, electrical work, guardrail installation grading and landscaping is completed.

The 159th Street Interchange Project is extending the life of the interchange, increasing traffic capacity and providing safe and convenient travel for Tollway customers. More than 13,000 vehicles use this interchange daily.

The Illinois Tollway began work at the 159<sup>th</sup> Street Interchange in 2018 to coordinate with future local improvements planned for 159<sup>th</sup> Street in coordination with coordinated with the Illinois Department of Transportation and Cook County. The project included rebuilding the existing 159<sup>th</sup> Street Bridge and reconstructing four ramps at the 159th Street Interchange. The project also provides for roadway lighting and drainage improvements, as well as landscaping work and the addition of sidewalks to improve pedestrian access in the area.

#### **Work Zone Safety**

Work zone speed limits are in effect in all construction zones 24/7 and drivers should continue to watch for changing traffic patterns and use caution, especially when workers are present.

The Illinois Tollway reminds motorists that the "Move Over Law" requires motorists to change lanes or to slow down and proceed with caution when passing any vehicle on the side of the road with hazard lights activated. If you see flashing lights ahead, please move over or slow down

Illinois State Police have zero tolerance for drivers speeding in work zones or failure to comply with the Move Over Law.

The minimum penalty for speeding in a work zone is \$375. Posted signs advise drivers of a \$10,000 fine and a 14-year jail sentence for hitting a roadway worker.

Penalties for failure to slow down or move over for a vehicle on the shoulder with flashing lights includes up to a \$10,000 fine, 2-year suspension of driving privileges and jail time, in extreme cases.
