The work under this contract is to be performed along the Elgin O'Hare Western Access Expressway (IL 390) between Illinois Route 83 (Busse Road) and York Road (M.P. 15.9 to M.P. 17) in Dupage County, Illinois. The work under this Contract shall consist of: construction of new Illinois Route 390 bridges over CTM Railroad and over Supreme Drive, Ramp P5 Bridge over Ramp P1\O8, and Elgin O'Hare (IL 390) mainline and ramp pavement from IL 83 to York Road (including drainage), signing, pavement marking, landscaping, and lighting.
