The work under this contract includes, but is not limited to: Reconstruction of the concrete median barrier; Reconstruction of the inside shoulders; Roadway lighting installation/upgrades; Installation of conduit for fiber optic cable and electrical cable; Drainage improvements; Erosion control; Pavement marking; Maintenance of traffic; and all other work as shown in the plans.
