Mr. Cerpa additionally presented a short video showcasing the Department of Diversity and Strategic Development's mission to provide technical assistance that will increase access to economic opportunities for disadvantaged, minority- and women-owned enterprise (D/M/WBE) firms, as well as small and veteran-owned businesses and historically underemployed individuals.

Upon conclusion of the item presentation, Committee Chair pro tem McConnaughay made a motion to approve placement of **Diversity Item 1** on the May Board of Directors meeting agenda with the Committee's recommendation for approval by the Board.
