The Illinois State Toll Highway Authority ("Tollway") held the Diversity & Inclusion Committee Meeting on Thursday, December 5, 2019 in the Boardroom of Tollway Headquarters in Downers Grove, Illinois. Committee Chair's Items

Committee Chair Davis entertained a motion to approve **Committee Chair's Item 1**, the Minutes of the regular Diversity & Inclusion Committee meeting held on May 16, 2019, as presented. Director Connolly made a motion to approve the minutes, seconded by Director McConnaughay. Committee Chair Davis asked that the roll be called on the motion, the vote of yeas and nays being as follows:

Executive Director's Items

Executive Director Alvarez stated that he has no items to report to the Committee.

Diversity & Strategic Planning Discussion

Without objection, Committee Chair Davis requested that the agenda be reordered to start with a video presentation. He called on Terry Miller, Chief of Diversity & Strategic Development, to present for the Committee a short video showcasing the department's mission to provide technical assistance that will increase access to economic opportunities for disadvantaged, minority- and women-owned enterprise (D/M/WBE) firms, as well as small and veteran-owned businesses and historically underemployed individuals.

Committee Chair Davis then called on Mr. Miller to provide an update for the Committee on the Tollway's diversity initiatives. <u>See attached presentation</u>.

Executive Director Alvarez asked Derek Messier, Chief Operating Officer, to provide a brief overview of efforts being made to increase economic opportunities through the unbundling of contracts. Mr. Messier stated that plans are underway within the Engineering Department to increase entry points for small and medium businesses in Tollway contract offerings between \$1M - \$5M and \$5 - \$10M. He highlighted that repackaging of projects is estimated to provide three times the number of packages anticipated to go out for bid in 2020, with a goal of 50 unbundled projects next year. He noted that a more complete overview of the plan will be presented at the next meeting of the Committee.



Adjournment

There being no further business before the Committee, Committee Chair Davis requested a motion to adjourn. A motion to adjourn was made by Director Connolly, seconded by Director McConnaughay. The motion was PASSED unanimously.

The Meeting was adjourned at approximately 1:28 p.m.
