The work to be performed pursuant to this permit is described as follows:

- Install protective shield and perform deck repairs on the 159<sup>th</sup> Street bridge over I-294.
- (2) Remove and replace a column supporting the eastbound I-80 to northbound I-294 ramp over mainline I-294.

All work in accordance with IDOT Contract No. 60F56. Design of protective shielding to be approved by the Tollway. Protective shield must extend all the way across the bridge. Lane closures to install protective shielding must be scheduled during low traffic volume at night. Temporary work areas subject to approval by the Tollway. A permit number is required to schedule lane and shoulder closures.

THIS PERMIT is subject to the following terms and conditions:

- 1. All work within the Tollway right-of-way shall be performed in accordance with the latest edition of the Illinois State Toll Highway Authority Standard Specifications.
- 2. The permittee shall provide a surety bond to guarantee compliance with the conditions of this permit. Said bond shall be filed with the Tollway on the Bond form provided, and be in form and amount acceptable to the Tollway prior to issuance of this permit.
- 3. Maintenance of traffic procedures used on the Tollway shall conform to the standard practices for traffic control as outlined in the special provisions for the project, the Illinois State Toll Highway Authority Standard Specifications, the Tollway Traffic Control Manual and any additional requirements as directed by the Tollway. Traffic control fines and penalties specified in the Tollway's Standard Specifications shall be imposed for any infractions for which notice is given to the permittee and which remain uncorrected within thirty minutes following said notice. Notice for purposes of this paragraph shall be defined as any communication, written or oral, between the Tollway, its agents or representatives and the permittee, its agents or representatives, that identifies an infraction and requests correction of said infraction. No notice shall be required to assess traffic control fines and penalties for subsequent infractions of the same type that have been identified.
- 4. Each and every one disturbed area within Tollway right-of-way shall be restored in accordance with the Illinois State Toll Highway Authority Standard Specifications.
- 5. The Illinois State Toll Highway Authority shall be named as an additional insured party in all liability insurance coverage required for the work. Certificates of Insurance showing the Tollway, as additional names insured shall be filed with the Tollway prior to issuance of this Permit and commencement of any work.
- 6. The permittee shall not park vehicles or store equipment and facilities within Tollway right-of-way without prior approval. Permittee shall not drive any vehicle, machine or equipment across or against the flow of traffic on the Tollway. Permittee is not authorized to use Tollway turnarounds (crossovers) or access the Tollway from a Tollway Oasis or Toll Plaza.
- 7. Permittee, its successors and assigns shall be responsible for and shall protect, indemnify and save harmless the Tollway, its employees, officers, and agents from any and all liability, loss, costs, fees, damages, expenses, claims, actions and suits of every kind and character, whether for financial losses, damage to property or injury to or death of any person whomsoever, arising or claiming to arise from any actions or inactions of permittee, its employees, agents and contractors to the fullest extent permitted by law, and liability shall not be limited by any insurance or bond required or provide by permittee.
- 8. Nothing herein contained shall be construed as prohibiting the Tollway, its officers, employees and agents from defending any claims, actions or suits brought against the Tollway based on alleged actions or inaction of permittee, or its employees, agents or contractors.
- 9. Permittee shall not perform any underground operations on Tollway property without locating Tollway facilities and utility facilities owned by others.
- 10. This Permit is revocable at the sole discretion of the Tollway.

## **Tollway Permit Section**

The Permit Section controls and monitors work and activities performed on Tollway property by outside entities that are not employed or under contract to the Tollway.

Standard Permits allow utility companies and municipalities to extend facilities across the Tollway to provide service. Standard permits (also referred to as crossing, utility and drainage permits) are granted to install facilities owned by others on Tollway property. Standard permits are approved by the Board of Directors.

Construction Permits allow construction work that in not part of a Tollway construction contract to be performed by an outside entity on Tollway property. The need for the work is often included in an agreement with the Tollway.

Authorization letters allow entry to Tollway property for engineering surveys, soil borings, utility and crossroad bridge inspections, minor repairs and all other minor work that is not performed under contract with the Tollway.

Truck Permits are issued to control the gross weight, weight distribution and dimensions of trucks, loads, and equipment using the Tollway system.

A One-Call Tollway Underground Facilities Locating Service is provided to locate and mark Tollway underground facilities for contractors, municipalities and utility companies that need to dig on Tollway property.

Utility relocation information is accessible here to help companies and municipalities and their consultants resolve conflicts with Tollway improvement projects.

The Permit Section also administers the Alternative Roadside Memorial Program.
