- Goal is to improve the economic climate for minority- and women-owned businesses

Unbundled and Small Business Set-Aside Construction Contracts

Unbundled and Small Business Set-Aside Construction Contracts

Tollway has awarded 120 contracts under \$5 million and 26 Small Business Set-Aside contracts since 2012

- Breaks up larger projects into a range of contract sizes and types
- Creates opportunities for small and diverse firms to compete for Tollway work as primes

Tollway continues to review types of opportunities that best fit criteria for unbundled and set-aside projects

Factors include safety, efficiency, scope and availability of contractors

Tollway will be implementing small business goals and "zero" goals on select construction contracts

Internal Workforce Diversity Subcommittee

Tollway internal diversity is at record levels

Proposed committee would develop strategies to further increase diversity of Tollway staff

Committee would include DAC volunteers and external human resource experts



New Veterans Initiatives

Proposed Veterans Initiatives

Partner with federal, state and local agencies to host outreach events targeted to veteran-owned firms

- Provide assistance with becoming registered with the state, technical assistance programs available and upcoming bid opportunities
- Offer workforce development assistance for individual veterans

Review veteran goals on construction and professional services contracts


Veteran commitments have exceeded Tollway goals by 32 percent

Pursue Veteran Set-Aside Program for construction

Contracts would be race and gender neutral

Establish workforce credit for hiring veterans

 Firms hiring and retaining non-Workforce Innovation and Opportunity Act eligible veterans would earn credits for future bids similar to ECP credits

Disparity Study Recommendations Immediate (by end of 2016)

Conduct regular seminars on DBE Program compliance

Continue Tollway's narrowly-tailored DBE Program

Use new Disparity Study data to set DBE goals on contracts

Create a Mentor/Protégé Program for construction

Develop a Tollway DBE Program document



Disparity Study Recommendations Mid-Term (by end of 2nd Quarter 2017)

Expand current "unbundling" efforts to professional services and goods and services contracts

Expand unbundling and set-aside program to non-construction contracts

Review prequalification requirements and specifications to ensure that DBEs and small firms are not unfairly disadvantaged

Develop performance measures for DBE Program success



Disparity Study Recommendations Long-Term (beyond 2nd quarter 2017)

Require bidders to maintain pricing information on all subcontractor quotes on larger projects

Consider measures to encourage prime contractors to utilize new DBEs

Implement an electronic contract data collection and monitoring system

Conduct regular DBE Program reviews



Diversity Advisory Council (DAC) Recommendations

DAC Recommendations – Policy Committee

Retain Diversity and Inclusion Committee and Diversity Advisory Council indefinitely

Shorten maximum length for Tollway goods and services contracts to no more than two years

Shorten maximum length for Tollway JOC contracts to no more than two years

Include marketing component in current and new technical assistance programs



Next Steps

Policy Committee

- Review Tollway sanction language and DBE and EEO Special Provisions regarding contractors not meeting diversity goals
- Conduct review of "best practices" from public and private sector programs in the heavy highway construction industry
- Review IDOT and Tollway construction standards and supplemental specifications to identify and remove any barriers
- Examine opportunities to remove financial barriers including access to capital, insurance and bonding requirements
- Identify any additional opportunities for unbundling
- Develop plan for measuring success of DAC recommendations

Develop and launch Mentor/Protégé Program for construction by end of 2016

Issue RFP for good and services technical assistance

Create construction bid checklist

 Continue development of Mentor/Protégé Program for construction



DAC Recommendations – Workforce Development Committee

Issue RFP for workforce development technical assistance

Create committee to work with top five trade unions to increase member diversity

Require Tollway contractors to submit EEO workforce projections prior to start of projects

Post contractor EEO compliance data online

Commission a workforce disparity study



Next Steps

Workforce Development Committee

- Develop ECP-eligible candidate referral system for contractors
- Collect and review EEO data to identify employment patterns by race and gender
- Obtain feedback on Tollway workforce development programs
- Review Tollway's role in enforcing EEO compliance
- Develop events and programs to market Tollway workforce development programs to contractors
