RAMP CLOSURES SCHEDULED TO BEGIN NEXT WEEK AT I-290 INTERCHANGE AT THE TRI-STATE TOLLWAY (I-294) AND REAGAN MEMORIAL TOLLWAY (I-88) Up to eight nights of full closure needed on northbound I-294 and eastbound I-88 ramps to westbound I-290

DOWNERS GROVE, IL – Overnight closures on the ramps connecting the northbound Tri-State Tollway (I-294) and the eastbound Reagan Memorial Tollway (I-88) to westbound I-290 are scheduled to begin next week and continue into December for Illinois Tollway construction. A detour will be posted.

Electronic message signs and construction signage will be put in place in advance to alert drivers to the overnight closures and detour. The temporary closures are necessary to provide a work zone and safely accommodate work. All work is weather dependent.

"As part of the Illinois Tollway's dedication to safety, we are committed to prioritizing the safety of both drivers and workers during construction," said Illinois Tollway Executive Director José Alvarez. "We understand the inconvenience that this approach to roadwork can cause, so we are always working to find ways when possible to reduce the impact of this disruption to our customers."

Beginning the week of November 18, overnight closures on the ramps connecting northbound I-294 and the eastbound Reagan Memorial Tollway (I-88) to westbound I-290 are scheduled to begin. Detours will be posted directing traffic onto I-290 eastbound and Mannheim Road where traffic will be routed through the interchange to access I-290 westbound. Please note, eastbound I-88 traffic will still be able to access northbound I-294 during these closures.

Full closures with detours are scheduled to begin after midnight and reopen by 5 a.m. on weeknights, with slightly later reopen times on the weekends, as weather permits. Up to eight nights of closures will be needed to complete the work and detailed closure information will be provided in the Tollway's Daily Construction Alerts and posted on the Tollway's website.

The closures will allow workers to safely install protective shielding on the I-294 bridges carrying traffic over the I-290 ramps to prepare for work in spring 2020 as part of the Central Tri-State Tollway (I-294) Project.



The closures are being coordinated with the local communities, the Illinois Department of Transportation, DuPage County, Cook County and local fire and police departments.

The Central Tri-State Tollway (I-294) will be rebuilt and widened between Balmoral Avenue and 95th Street to provide congestion relief, reconstruct old infrastructure to meet current and future transportation demand and address regional needs. Work on the \$4 billion Central Tri-State Project began in 2018 to repair, resurface and widen I-294 to five lanes between Balmoral Avenue and Wolf Road in Franklin Park, as well as to reconstruct bridges, barrier walls, medians and shoulders throughout the corridor in advance of roadway improvements.

Work Zone Safety

The Illinois Tollway is committed to ensuring that the Central Tri-State Tollway (I-294) and local roads remain safe for both drivers and workers during construction, which is part of the agency's overall commitment to roadway safety.

Construction zone speed limits are in effect in all construction zones 24/7 and drivers should continue to watch for changing traffic patterns and use caution, especially when workers are present. On I-294, a 45 mph work zone speed limit is in effect throughout the construction season.

The Illinois Tollway reminds motorists that the "Move Over Law" requires motorists to change lanes or to slow down and proceed with caution when passing any vehicle on the side of the road with hazard lights activated. If you see flashing lights ahead, please move over or slow down.

Illinois State Police have zero tolerance for drivers speeding in work zones or failure to comply with the Move Over Law.

The minimum penalty for speeding in a work zone is \$250. Posted signs advise drivers of a \$10,000 fine and a 14-year jail sentence for hitting a roadway worker.

Penalties for failure to slow down or move over for a vehicle on the shoulder with flashing lights includes up to a \$10,000 fine, 2-year suspension of driving privileges and jail time, in extreme cases.

The Illinois Tollway's 15-year, \$14 billion capital program, *Move Illinois: The Illinois Tollway Driving the Future*, is improving mobility, relieving congestion, reducing pollution, creating as many as 120,000 jobs and linking economies throughout the region. The first seven years of *Move Illinois* is on schedule and within budget, delivering the rebuilt and widened Jane Addams Memorial Tollway (I-90) as a state-of-the-art 21st century corridor and opening a new interchange connecting the Tri-State Tollway (I-294) to I-57. Progress continues on projects addressing the remaining needs of the existing Tollway system, delivering the Elgin O'Hare Western Access Project and planning for emerging projects, including reconstruction of the Central Tri-State Tollway (I-294).

About the Illinois Tollway

The Illinois Tollway is a user-fee system that receives no state or federal funds for maintenance and operations. The agency maintains and operates 294 miles of roadways in 12 counties in Northern Illinois, including the Reagan Memorial Tollway (I-88), the Veterans Memorial Tollway (I-355), the Jane Addams Memorial Tollway (I-90), the Tri-State Tollway (I-94/I-294/I-80) and the Illinois Route 390 Tollway.
